#### Option B: To provide public comment by video conference (Zoom)

Public testimony is limited to three (3) minutes per speaker; a speaker's time may not be transferred to another speaker. To request to speak during public comment, please click the "Raise Hand" button on the Zoom toolbar. Speaker must be present when called to speak; staff will announce the speaker's name, as listed on Zoom, and unmute the microphone to speak (audio only).
