SUBJECT: APPROVAL OF SEVENTH AMENDMENT TO AGREEMENT FOR CONSULTANT SERVICES, WITH **ECS** IMAGING, INC., FOR ELECTRONIC DOCUMENT IMAGING (SCANNING) AND INDEXING

**SERVICES** 

On March 17, 2020, the City Council declared a local emergency in response to the global COVID-19 pandemic. Due to the emergency circumstances, and the closure of City Hall to the public until further notice, the City's outsourced scanning project was placed on hold.

When City Hall initially reopened in June 2021, staff negotiated an amendment to continue with the scanning services and the City Council approved the Sixth Amendment to the Agreement for Consultant Services, with ECS Imaging, Inc., for Electronic Document Imaging (Scanning) and Indexing Services to extend the Agreement to June 30, 2022.

Unfortunately, due to the ongoing pandemic and a reduction in staffing, the City was unable to continue with the scanning project until March of 2022. Staff is optimistic that scanning services will continue through 2023.

The terms of the original agreement allow for the City, at its option, to extend the agreement upon providing written notice of its intent to the consultant, not less than thirty (30) days prior to the expiration of the initial term. As part of the negotiation with ECS Imaging, Inc., in March 2022, the consultant was amenable to extend the term of the agreement to June 30, 2023.

The proposed amendment to the agreement has been reviewed by the City Attorney and approved as to form.

#### RECOMMENDATION

Staff respectfully recommends the City Council approve the Seventh Amendment to the Agreement for Consultant Services, with ECS Imaging, Inc., to extend the Agreement for Electronic Document Imaging (Scanning) and Indexing Services to another term, ending June 30, 2023.

The Agreement for Consultant Services, for Electronic Document Imaging Scanning and Indexing Services, is set to expire June 30, 2022. Unfortunately, due to the COVID-19 pandemic, the City was unable to utilize a majority of the scanning services, but is set to re-negotiate for services beginning in July 2022 at the contract price of \$25,000.

As per the terms of the agreement, the City may, at its option, extend the agreement an additional term of one year upon providing written notice of its intent to extend not less than thirty (30) days prior to the termination date. Such extension shall be in accordance with the same service rates and conditions, as set forth in the agreement.

This letter serves as the City's formal written notice of its intent to extend the Agreement for another term, to June 30, 2023. If you are in accord with this extension, please sign and return this cover letter with the enclosed amendment.

### SEVENTH AMENDMENT TO AGREEMENT BETWEEN CITY OF AGOURA HILLS AND ECS IMAGING, INC.

### Electronic Document Imaging (Scanning) and Indexing Services

THIS SEVENTH AMENDMENT is made and entered into as of June 22, 2022, by and between the City of Agoura Hills, a municipal corporation (hereinafter referred to as "City"), and ECS Imaging, Inc., (hereinafter referred to as "Consultant"). In consideration of the mutual covenants and conditions set forth herein, the parties agree as follows:

- 1. This Amendment is made with the respect to the following facts and purposes:
- a. On May 14, 2015, the City and Consultant entered into that certain Agreement entitled "Agreement for Consultant Services" for Electronic Document Imaging (Scanning) and Indexing Services, in the amount of Forty Thousand Dollars and Zero Cents (\$40,000) with a termination date of June 30, 2016.
- b. The Agreement allows for extending the agreement and the First Amendment (\$40,000) was entered into, at the same Consultant price and conditions set forth in the original agreement, with a termination date of June 30, 2017, for a total contract amount of Eighty Thousand Dollars and Zero Cents (\$80,000).
- c. The Second Amendment (\$50,000) was entered into, at the same Consultant price and conditions set forth in the original agreement, with a termination date of June 30, 2018, for a total contract amount of One Hundred Thirty Thousand Dollars and Zero Cents (\$130,000).
- d. The Third Amendment (\$50,000) was entered into, at the same Consultant price and conditions set forth in the original agreement, with a termination date of June 30, 2019, for a total contract amount of One Hundred Eighty Thousand Dollars and Zero Cents (\$180,000).
- e. The Fourth Amendment (\$50,000) was entered into, at the same Consultant price and conditions set forth in the original agreement, with a termination date of June 30, 2020, for a total contract amount of Two Hundred Thirty Thousand Dollars and Zero Cents (\$230,000).
- f. The Fifth Amendment (\$25,000) was entered into, at the same Consultant price and conditions set forth in the original agreement, with a termination date of June 30, 2021, for a total contract amount of Two Hundred Fifty-Five Thousand Dollars and Zero Cents (\$255,000), however, due to the COVID-19 pandemic, City Hall was closed to the public during this time period and no scanning services were utilized nor was any of the appropriated \$25,000 in the budget expended.
- g. The Sixth Amendment was entered into, with the re-opening of City Hall in June 2021, to extend the term of the Agreement to June 30, 2022, to complete the scanning services, at the same Consultant price and conditions set forth in the original agreement. However, due to the COVID-19 pandemic, limited scanning services were utilized and only a small portion of the appropriated \$25,000 in the budget was expended.

- h. Now, with the full re-opening of City Hall, and the ability for staff to continue scanning services, the parties now desire to enter into a Seventh Amendment to the Agreement to **extend the term of the Agreement to June 30, 2023**, to complete the scanning services, at the same Consultant price and conditions set forth in the original Agreement, and to amend the Agreement as set forth in the Amendment.
- 2. Section 1 of the Agreement entitled "**TERM**" is hereby amended to read as follows:

"This Agreement shall remain and continue in effect until tasks herein are completed, but in no event later than June 30, 2023, unless sooner terminated pursuant to the provisions of this Agreement."

3. Except for the changes specifically set forth herein, all other terms and conditions of the Agreement shall remain in full force and effect, including any Exhibits, hereby incorporated by reference.
