JUNE 8 (W) by E-120	City Council adopted Resolutions calling and giving notice of a General Municipal Election for the election of certain officers, requesting the Board of Supervisors consolidate with the County of Los Angeles General Election, determining candidate statement regulations, and giving notice to the County to render specified services to the City of Agoura Hills. <i>(Elections Code §§ 1002, 10400, 10402, 10403, 1200, and 13307)</i>
JULY 1 (F) by E-113	"Notice of Election" for City Council candidates shall be posted and published by the City Clerk in The Acorn and Ventura County Star newspapers. (Elections Code § 12101, Government Code § 6061)
JULY 18 (M) – E-113	NOMINATION PERIOD
AUGUST 12 (F) E-88 BY <u>4:00 P.M.</u> City Hall Closed on Weekends	Nomination papers to be obtained and filed during this period for three (3) City Council seats. Each candidate shall be proposed by not less than 20 nor more than 30 registered voters of the City of Agoura Hills. Candidate Statements must be filed during this period. <i>(Elections Code §§ 10220, 10224, 10407, 13307)</i>
AUGUST 1 (M)* BY 5:00 P.M. *Next Business Day	<b>FIRST SEMI-ANNUAL STATEMENT DEADLINE</b> Last day to file Semi-Annual statement for candidates and committees for period ending June 30, 2022. ( <i>Government Code § 84200</i> )
AUGUST 12 (F) E-88	Last day to file resolution with the Board of Supervisors and Registrar-Recorder/County Clerk requesting consolidation with General Election. <i>(Elections Code §§ 10400, 10402, 10403)</i>
AUGUST 12 (F) E-88 BY 4:00 P.M.* *City Hall Closes at 4pm	<b>END OF NOMINATION PERIOD – FILING DEADLINE</b> Last day for candidates to file nomination papers including (optional) candidate statement (not to exceed 200 words). Form 700 - <i>Statement of Economic Interests</i> , and Local Forms 10, 20, and 30, or 50 (if filing Form 470) are also due at the time of filing nomination papers. ( <i>Elections Code §§ 10220, 10224, 10407</i> )
AUGUST 12 (F) E-88 BY 4:00 P.M.* *City Hall Closes at 4pm	Last day for candidate to withdraw nomination papers after being filed with the City Clerk, except when nomination period is extended ( <i>Elections Code § 10224</i> ).
AUGUST 17 (W) E-83	<b>FILING NOMINATION PAPERS - EXTENSION</b> If nomination documents for an incumbent are not filed by 4:00 p.m. on August 12, 2022, the nomination period shall be extended until August 17, 2022, at 5:00 p.m, for persons other than the incumbent <i>(Elections Code § 10225).</i>
AUGUST 13*(Sa) –E-87* AUGUST 22 (M) E-78 *City Hall Closed on Weekend	Public Examination Period if nomination period was not extended (Elections Code § 13313).

AUGUST 18 (Th) BY 5:00 P.M.	E-82 Last day candidate statement may be withdrawn, but not changed, after being filed with the City Clerk, if an incumbent does not file <i>(Elections Code §13307(a)(3))</i> .

Secretary of State shall hold a public drawing to determine the order of candidate names to appear on the ballot by randomly drawing each letter of the alphabet. (Elections Code § 13112) AUGUST 19 (F) E-81 Last day for City Clerk to file a certified list of gualified candidates with the County. (Elections Code § 10403) AUGUST 25 (Th) E-75 Last day to cancel an election, due to insufficient number of candidates. (Elections Code § 10229) SEPTEMBER 12 (M) - Filing period for write-in candidates to file with the City Clerk. OCTOBER 25 (Tu)E-57/14 (Elections Code §§ 8600, 8601, 10103) City Hall Closed on Weekends SEPTEMBER 22 (Th) City Clerk notifies candidates of first campaign filing requirement due on September 29, E-47 2022. FIRST PRE-ELECTION STATEMENT DEADLINE SEPTEMBER 29 (Th)

BY 5:00 p.m. Last day to file campaign statement for candidates and committees showing all receipts and expenditures beginning on the day after the closing date of the last statement filed, or July 1, 2022, if no previous statement has been filed, up to and including September 24, 2022 (*Government Code § 84200.7(b)(1)(2), 84200.8*).

SEPTEMBER 29 (Th) – Official Sample Ballot Booklet mailed to each registered voter during this period. OCTOBER 18 (Tu)E-40/21 (Elections Code § 13303)

OCTOBER 6 (Th) E-33	City Clerk notifies candidates of second campaign filing requirement due on October 13, 2022.
OCTOBER 10 (M) – E-29 NOVEMBER 1 (Tu) E-7	Voters may file Vote by Mail applications; both dates inclusive. (Elections Code § 3001(b) Per AB 860, approved by the Governor on June 18, 2020, the Los Angeles County Elections Division shall begin mailing Vote by Mail ballots to every registered voter in the County. The distribution of vote by mail ballots to all registered voters does not prevent a voter from voting in person at a vote center.
OCTOBER 10 (M) – E-29 NOVEMBER 8 (Tu) E	Emergency Vote by Mail period. Any voter may request a Vote By Mail ballot if they are unable to go to a Vote Center because of confinement due to an illness ( <i>Elections Code § 3021</i> )
OCTOBER 13 (Th) E-26 BY 5:00 p.m.	<b>SECOND PRE-ELECTION STATEMENT DEADLINE</b> Last day to file campaign statement for candidates and committees for the period covering September 25, 2022, through October 8, 2022 ( <i>Agoura Hills Municipal Code § 21006(e) E44-31</i> ).
OCTOBER 18 (Tu) E-21	Last day County to mail Official Sample Ballot Booklet to each voter (Elections Code § 13303).
OCTOBER 20 (Th) E-19	City Clerk notifies candidates of third campaign filing requirement due on October 27, 2022.
	6 Independent expenditures and campaign contributions in excess of \$5.00 received during this time must be reported to the City Clerk within 48 hours of receipt or expenditure via personal delivery, mailgram, telegram, or guaranteed overnight ( <i>Agoura Hills Municipal Code § 21007</i> ).
OCTOBER 24 (M) E-15	Last day to register to vote in November 8, 2022, General Municipal Election ( <i>Elections Code</i> §§ 2102, 2107).
OCTOBER 25 (Tu) E-14	Last day to file as a write-in candidate. (Elections Code §§ 8600, 8601).
OCTOBER 27 (Th) E-12	Last day for City Clerk to file a certified list of qualified write-in candidates with the County.
OCTOBER 27 (Th) E-12 BY 5:00 p.m.	<b>THIRD PRE-ELECTION STATEMENT DEADLINE</b> Last day to file campaign statement for candidates and committees for the period covering October 9, 2022, through October 22, 2022 ( <i>Government Code § 84200.8</i> ).
OCTOBER 28 (F) By E-7	Notice of Nominees for Public Office posted and published by the City Clerk in The Acorn and Ventura County Star newspapers ( <i>Elections Code § 12110, Government Code § 6061</i> ).
OCTOBER 29 (Sa) E-10	Vote Centers open beginning 10 days prior to election day. (Elections Code § 4007)
BY OCTOBER 29* E-10 (*Saturday)	Notice of Central Tally Center for Counting Ballots posted and published by the County in a newspaper of general circulation ( <i>Elections Code § 12109</i> ).
NOVEMBER 1 (Tu) E-7	Last day to file Vote by Mail application. (Elections Code § 3001)

- **DECEMBER 13 (Tu)** City Council Reorganization (Installation) and Reception.
- DECEMBER 14 (W) City Clerk to send City Council reorganization notices to Secretary of State, County of Los Angeles, and cities. Fair Political Practices Commission to be notified of election date, candidates, and elected officeholders.
- DECEMBER 14 (W) City Clerk notifies each Councilmember-Elect of Assuming Office, Form 700 Statement of Economic Interests and AB 1234 Ethics Training filing requirements due January 13, 2023.
- JANUARY 13, 2023 (F) Last day for new Councilmembers to file Form 700 Statement of Economic Interests (Government Code § 87202 states that Councilmember must file within 30 days of assuming office).
- JANUARY 13, 2023 (F) Last day for new Councilmembers to file an AB 1234 Public Service Ethics Education Proof of Participation Certificate (with a minimum of two hours training) - City Clerk will provide links for online training (*Government Code § 53235*)
- JANUARY 19, 2023 (Th) Candidates notified of campaign filing requirement due on February January 31, 2023.

### JANUARY 31, 2023 (Tu) SECOND SEMI-ANNUAL STATEMENT DEADLINE

- BY 5:00 p.m. Last day to file campaign statement for candidates and committees for the period covering October 23, 2022, through December 31, 2022, unless termination Forms 410 and 460 were filed before December 31, 2022. (*Government Code § 84200*).
- APRIL 3, 2023\* (M) Last day for all officeholders to file an Annual, Form 700 Statement of Economic Interests (Government Code § 87203).
- JULY 20, 2023 (Th) All candidates, officeholders and committees notified of campaign filing requirement due on July 31, 2023.

## JULY 31, 2023 (M) FIRST SEMI-ANNUAL STATEMENT DEADLINE

BY 5:00 p.m.

Last day to file campaign statement for candidates and committees for the period covering January 1, 2023, through June 30, 2023 (Government Code § 84200).
