Written public comments submitted at the meeting are not read aloud by the staff. Any inperson attendees in the Community Conference Room will be required to follow the current State and County public health guidelines. Please silence all cell phones and other electronic devices during the meeting.

<u>Option B</u>: To provide public comment by video conference (Zoom)

Public testimony is limited to three (3) minutes per speaker; a speaker's time may not be transferred to another speaker. To provide public comment live at the meeting, access the meeting remotely via Zoom (see link above). To request to speak during public comment, please click the "Raise Hand" button on the Zoom toolbar. Speaker must be present when called to speak; staff will announce the speaker's name, as listed on Zoom, and unmute the microphone to speak (audio only). Prior to speaking, state first and last name and provide city of residence for the record. The microphone will be muted by staff when three (3) minutes have expired.
