SUBJECT: CONDUCT INTERVIEWS OF QUALIFIED APPLICANTS AND SELECTION OF APPOINTEE TO FILL VACANCY OF CITY COUNCIL SEAT AND CONSIDER THE ADOPTION OF RESOLUTION NO. 22-2020; APPOINTING AN INDIVIDUAL TO FILL THE CITY COUNCIL VACANCY CREATED BY THE RESIGNATION OF COUNCILMEMBER LINDA L. NORTHRUP

On August 15, 2022, Councilmember Linda L. Northrup submitted a resignation letter creating a vacancy for her position on the City Council with the unexpired term through December 2024. On August 24, 2022, the City Council considered the options allowed under California Government Code Section 36512 for filling the vacant City Council seat, and direction was given to staff to do so through a formal interview and appointment process.

Applications for Appointment to City Council Vacancy were accepted from applicants between August 25, 2022, through September 8, 2022.

All applicants are required to meet the following eligibility criteria:

1. Be 18 years of age or older,
2. Be a resident of the incorporated area of the City of Agoura Hills,
3. Be a registered voter at the applicant's current place of residence in Agoura Hills,
4. Be able to certify that he/she meets the eligibility criteria requirements and is willing to serve in the office for the remainder of the unexpired term, and
5. Not be a certified candidate for the November 8, 2022, General Municipal Election.

At the close of the application period, 15 applications were received and voter registration was confirmed with the County. Refer to Attachment A to view a complete list of qualified applicants and copies of their applications.

Prior to the start of the interview process, all qualified applicants will be seated in a separate room adjacent to the Council Chambers, where a staff member will be assigned

to assist in facilitating the orderly movement of applicants to and from the Council Chambers. The order applicants will be interviewed will be based on a random live drawing conducted by the City Clerk from the staff dais. Once a name is announced, a designated staff person will summon the selected applicant to be interviewed by the City Council in the Council Chambers.

Each interview will begin with a three-minute period for the applicant to address the City Council and explain the reason(s) they should be appointed to fill the vacant City Council seat. Following the initial three minutes, each Councilmember will then have an opportunity to ask any additional questions to each applicant. After an applicant's interview ends, the next applicant's name will be drawn by the City Clerk. This process will repeat until all applicants have been interviewed.

At the conclusion of the interview process, there will be a brief meeting break to allow Councilmembers an opportunity to review their notes and determine their individual top applicant choice. At this time all applicants will also be allowed to join the audience in the Council Chambers to be present for the City Council discussion.

Following the break, each Councilmember will announce their single top applicant choice, resulting in a list containing a maximum of four applicants. It is worth noting the possibility this list could have less than four applicants if multiple Councilmembers choose the same top applicant or if there are no more than four total applicants to begin with.

The City Council will then openly discuss the list of top applicants to determine if there is majority support for a particular applicant. For clarification, a "majority" of the existing four-member body would be considered at least three members of the City Council. If there is majority support for a single applicant, the City Council has the option to make a formal motion to appoint the selected applicant at the same meeting of the interviews. In this scenario, the Oath of Office would be administered at the beginning of the next regularly scheduled meeting of the City Council on September 28, 2022, allowing the newly sworn Member of the City Council to be seated at the dais at that time and participate in the remaining items of the Agenda that evening.

In the event a majority of the City Council is unable to agree on a particular applicant, the City Council has agreed to use a ranking system, wherein each Councilmember will assign a unique point value to each of the top applicants. For example, assuming the list includes four applicants, the ranking system would be as follows:

- Choice #1 = 4 points
- Choice #2 = 3 points
- Choice #3 = 2 points
- Choice #4 = 1 point

Once each Councilmember completes their ranking of top applicants, they will submit their individual rankings to the City Clerk. The City Clerk will add each of the top

applicants' point totals from each Councilmember and the applicant with the most total points will be the selected appointee.

At that point, the City Council could then exercise its option to make a formal motion to adopt the resolution appointing the applicant that received the most points at the same meeting of the interviews. As previously mentioned, the Oath of Office would be administered at the beginning of the next regularly scheduled City Council meeting on September 28, 2022, allowing the newly sworn Member of the City Council to be seated at the dais at that time and participate in the remaining items of the Agenda that evening.

As required by the California Government Code, the appointment must be completed within 60 days of the commencement of the City Council seat vacancy, which would be no later than October 14, 2022. If for any reason, the City Council is unable to agree on an appointment by that date, the vacancy would need to be filled through a special election to be held on March 7, 2023.

RECOMMENDATION

Staff respectfully recommends the City Council:

1. Select one of the top applicants to be appointed to fill the vacancy on the City Council, and
2. Approve the attached Draft Resolution No. 22-2020, with the selected appointee's name inserted, and
3. Confirm the Oath of Office for the appointee will be at the beginning of the next regularly scheduled meeting of the City Council on September 28, 2022, allowing the newly sworn Member of the City Council to be seated at the dais at that time and participate in the remaining items of the Agenda that evening.

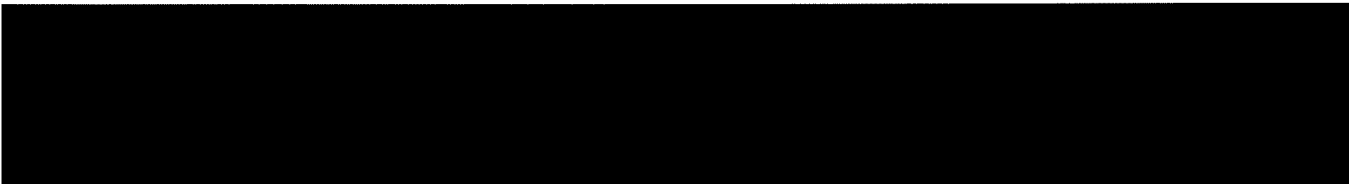

Third, I'd love to see us encourage small business growth and be a destination for quality businesses. Our family loves to eat, loves great coffee and we often find ourselves having to venture outside the community to find these quality places. Even if it's only to Westlake or Thousand Oaks or Calabasas, we'd love to see more quality stores and healthy, fast casual restaurants open in Agoura Hills.

WHAT VISION DO YOU HAVE FOR THE FUTURE OF THE CITY OF AGOURA HILLS?

For the most part, my goals would be to keep Agoura Hills similar to how it is now. The charm of the town is the small-town feel it provides, while still being close to greater Los Angeles and close enough to Ventura and Santa Barbara. By providing incentives for businesses, quality shops and restaurants, greater community involvement and engagement while maintaining our current safe, small-town feel, will be key to a prosperous future for the city.
