SUBJECT: APPROVE PURCHASE OF 2023 TOYOTA HIGHLANDER HYBRID

FROM HAMER TOYOTA FOR THE CITY OF AGOURA HILLS VEHICLE

FLEET IN THE AMOUNT OF \$54,000

On April 27, 2022, the City Council approved the purchase of a 2022 Toyota Highlander Hybrid from Toyota of Huntington Beach in the amount of \$48,757.87. Subsequently, as a result of supply chain, manufacturing, and dealership vehicle allocation issues on the Toyota side, the City continues to wait on communication from Toyota of Huntington Beach that a vehicle has been received. City staff's last communication with the representative from Toyota in late September indicated allocations continue to remain limited. The representative also indicated that it understood if the City wished to discontinue its relationship with the dealership as a result of these supply chain issues.

As a result of this challenge, City staff discussed and re-evaluated the issue and began to reach out to individual dealerships on the possible availability of this vehicle within their inventory. Initially receiving similar responses concerning limited dealership vehicle allocations, a recent communication from one dealership identified availability of a vehicle currently in production and scheduled for delivery to Hamer Toyota. The vehicle is a 2023 Highlander Hybrid with the same specifications previously desired.

Due the nature of the overall limited inventory and limited dealership allocations, the City was advised a deposit was needed to ensure the vehicle would be allocated for the City of Agoura Hills. As the City Council had previously approved the purchase of this type of vehicle, City staff initiated a deposit of \$3,000 to take the vehicle out of the dealership's available sale inventory and ensure the City would receive the car upon its delivery. As the vehicle is a 2023 model versus a 2022 model, there is an additional \$5,242.13 cost increase from the previously approved purchase, bringing the total price for the 2023 Toyota Highlander Hybrid to \$54,000.

Funding for the Highlander Hybrid was budgeted in the amount of \$48,757.87 for FY 2022-23 and is available under the South Coast Quality Air Management District Fund (SCAQMD). The vehicle has also been authorized for purchase by the SCAQMD staff as a low emission approved vehicle. Due to the amount slightly exceeding the budgeted amount, staff is respectfully requesting the authorization of additional SCAQMD Funds be appropriated in the amount of \$5,242.13 to cover the final vehicle cost.

As a reminder, the City has an internal fleet of eleven vehicles consisting of a combination of hybrid and gasoline type varieties. As the fleet over time begins to age, replacement of vehicles is needed to assist in reduction of future maintenance cost, and allow the City time to transition the fleet to more fuel efficient and sustainable vehicles.

While the City is preparing to modify its fleet to a more sustainable variety (electric), and anticipates the future purchase of an electric vehicle in the coming fiscal years, a mid-size vehicle was needed to assist the Code Enforcement staff with the various tasks associated with code enforcement activity. Additionally, the City is continuing to exam the infrastructure needed to accommodate the addition of an electric fleet.

Staff reviewed the specification sheet and retail worksheet submitted and concluded that Hamer Toyota met the requirements of the City. Should the City Council approve award of the contract, staff will begin the coordination of work needed to purchase and secure the vehicle. City staff has been advised the vehicle would be delivered to Hamer Toyota in late November of 2022.

RECOMMENDATION

Staff respectfully recommends the City Council approve purchase of a 2023 Toyota Highlander Hybrid from Hamer Toyota in the amount of \$54,000 and authorize the additional \$5,242.13 from the SCAQMD funds.




