INTERGOVERNMENTAL, SPECIAL PURPOSE COMMITTEE, & DEPARTMENTAL REPORTS

In celebration of the City of Agoura Hills 40th Anniversary – 40 Facts for 40 Years, Mayor Lopez presented two facts about Agoura Hills including: 1) the area was one of the stops in California on the famous Pony Express Route of the 1860s and Reyes Adobe Days was formerly known as Pony Express, an annual western-themed parade that honored the history of the Pony Express, and 2) Lapworth Castle was built, over a 30-year period beginning in 1929, by Englishman Charles Lapworth who purchased 10 acres of Las Virgenes Rancho to build his family's dream home. Much of the home was built using scraps and salvage from other construction sites and the house has also served as a desirable Hollywood set for westerns and thrillers.
