SUBJECT: CONDUCT A PUBLIC HEARING AND ADOPT RESOLUTION NO. 22-

2025, APPROVING COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAMS AND PROJECTS FOR THE 49th PROGRAM YEAR

(JULY 1, 2023 – JUNE 30, 2024)

The request before the City Council is to conduct a public hearing to consider approval of Resolution No. 22-2025, approving Community Development Block Grant (CDBG) Programs and Projects for the 49th Program Year (July 1, 2023 – June 30, 2024).

Community Development Block Grant (CDBG) funds are allocated on an annual basis to municipalities by the Federal Housing and Urban Development Department (HUD) and administered through the Los Angeles County Development Authority (LACDA). Funding for participating cities of the Los Angeles Urban County CDBG Program is based upon the total number of participating cities and on the cities' needs to provide housing, economic and social services, and community development opportunities that principally benefit seniors and persons of low to moderate income levels, aid in the prevention of neighborhood blight, and meet other urgent community development needs due to natural disasters or other emergencies. The City of Agoura Hills ("City") has participated in the CDBG Program since 1984.

While the City Council has flexibility in selecting programs and projects that best suit the City's needs, these programs and projects must also comply with the specific federal qualification criteria of benefiting persons of low to moderate income, including seniors, and certain public projects for compliance with the Americans with Disabilities Act (ADA). Most recently, the City Council allocated CDBG funds for this past fiscal year towards the Recreation and Event Center Outdoor Accessibility Project, in addition to the annual allotment for senior social services classes being offered through the Community Services Department. These classes, which include various topics such as caregiver support, health care, and finances, are provided by Senior Concerns and have been provided via virtual meetings, due to the COVID-19 concerns.

After meeting with the Community Services Subcommittee on September 29, 2022, the subcommittee recommended the following: 1) to continue the support for our Senior Social Services Program and 2) designate the remaining funds towards making various playground accessibility improvements at one of the City's parks.

The LACDA estimated the City's CDBG allocated funds for the 2023-2024 Program Year to the following amounts:

LACDA will not release final appropriations from HUD until later in the spring of 2023.

Chumash Park's project will be added to the current Fiscal Year 2022-2023 and the scope of work will consist of making improvements to the path of travel leaving Medea Valley Drive to the playground area, including the removal of the concrete areas surrounding the restrooms. Accessibility improvements will also be made surrounding the playground including replacing existing benches with ADA compliant ones.

The preliminary engineer's cost estimate for the Chumash Park Project came in at approximately \$192,683.00 which was significantly higher than originally anticipated. Construction and concrete costs were identified as the main contributors to the cost estimate.

Since this is a preliminary estimate it should be noted that costs for building materials may continue to rise due to supply demands. Staff will have a better evaluation of costs once the project goes through the bidding process.

Morrison Park will be the next site for consideration once any remaining or future funds become available. Improvements will consist of repairing the parking lot and paths of travel leading to the playground area.

Should the City Council approve Resolution No.22-2025 the next step would be to get final approval from the LACDA. Following those required approvals, staff anticipates the bidding process to begin shortly after the new calendar year.

RECOMMENDATION

Staff respectfully recommends the City Council conduct a public hearing and adopt Resolution No.22-2025, approving Community Development Block Grant (CDBG) Programs and Projects for the 49th Program Year (July 1, 2023 – June 30, 2024) and adding Chumash Park to the current Fiscal Year 2022-2023.

RESOLUTION NO. 22-2025

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF AGOURA HILLS, CALIFORNIA, APPROVING COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAMS AND PROJECTS FOR THE 49th PROGRAM YEAR (JULY 1, 2023 – JUNE 30, 2024)

- **WHEREAS**, on August 22, 1974, the President of the United States signed into law the Housing and Community Development Act (Act) of 1974; and,
- WHEREAS, the primary goals of Title I of the Act are the development of viable urban communities by providing decent housing and a suitable living environment and expanding economic opportunities, principally for persons of low and moderate income, and certain public projects for compliance with the Americans with Disabilities Act (ADA); and,
- WHEREAS, the City of Agoura Hills estimates receiving \$68,000 of allocated funds in federal Community Development Block Grant (CDBG) funds to further the attainment of these goals during Fiscal Year 2023-2024; and,
- WHEREAS, the City Council has published information regarding eligible activities under the Act and has conducted a duly-noticed public hearing on November 9, 2022, at 6:00 p.m. in the Council Chambers of City Hall, 30001 Ladyface Court, Agoura Hills, California; and,
- **WHEREAS**, the notice of the public hearing was posted and advertised pursuant to applicable federal, state and local laws; and,
- **WHEREAS**, both oral and written testimony was presented to the City Council at the public hearing.
- **NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Agoura Hills as follows:
- <u>Section 1</u>. That the City of Agoura Hills desires to fund eligible CDBG projects with the 49th Program Year funds.
- <u>Section 2</u>. That City staff is hereby directed to submit to the Los Angeles County Development Authority, through this document, the City's intent to approve and fund CDBG projects.
- <u>Section 3</u>. That City staff is hereby directed to prepare and submit documentation required for the approval and implementation of the 49th Program Year CDBG projects.

Section 4. That for planning purposes, the City's estimated annual allocation for the upcoming 2023-2024 Program Year is estimated at \$68,000 and those funds will be utilized for: 1) eligible senior social service programs, not to exceed (\$10,000) of the Program Year allocation, including senior advocates information and resources, support groups for senior caregivers and care-giving spouses, and legal and financial services to seniors; and 2) allocating the remaining balance of funds towards the Chumash Park Rehabilitation Project; and 3) add the Chumash Park Rehabilitation Project to the current 2022-2023 Program Year.

<u>Section 5</u>. That City staff is authorized to perform modifications to the approved projects, as required, to conform to CDBG requirements, and to provide for the expedient expenditure of funds.

<u>Section 6</u>. That the Mayor and/or City Manager are authorized to execute the contractual and related documents to be prepared by the County of Los Angeles that are required for the implementation of projects set forth herein.
