SUBJECT: NOTICE OF COMPLETION FOR THE FISCAL YEAR 2022-23 ANNUAL CONCRETE REPAIR PROJECT; NIB 18-05(5)

On August 10, 2022, the City Council approved the one-year contract extension for the Fiscal Year 2022-23 Annual Concrete Repair Project; NIB 18-05 (5), to FS Contractors, Inc., in the amount of \$85,000. The City has contracted with FS Contractors, Inc., the past four (4) years to repair damaged concrete throughout the City. This fiscal year's work included the following:

- Removing and replacing 3,761 square feet of sidewalk
- Repairing 24.5 linear feet of curb and gutter
- Removing and replacing four (4) ADA ramps

FS Contractors Inc., completed the project ahead of the approved schedule, with no change orders being issued. The total project cost of \$83,398.27 is within the funds appropriated in the Fiscal Year 2022-23 Budget. The work was performed to the satisfaction of staff and is expected to serve the community well for many years to come.

RECOMMENDATION

Staff respectfully recommends the City Council:

1. Approve, and accept as complete, the work of FS Contractors, Inc., for the Fiscal Year 2022-23 Annual Concrete Repair Project; NIB 18-05(5); and
2. Authorize the Director of Public Works to sign the Notice of Completion for the project, and authorize the City Clerk to forward the Notice of Completion to the County Recorder for recordation.
