REPORT OF CLOSED SESSION

There was no Closed Session.

APPROVAL OF AGENDA

ORAL COMMUNICATIONS

Anthony Pecoraro, 3965 N. Ceanothus Place, #I, Calabasas, representing the Tenants Alignment Association, distributed information to the Council; expressed his concerns with the ownership of apartment complexes in Agoura Hills and tenants being charged utilities; reported that the City of Calabasas had implemented a rental registration program that tracks all rental increases; and encouraged the City of Agoura Hills to do the same.

INTERGOVERNMENTAL AND SPECIAL PURPOSE COMMITTEE REPORTS

Larry Misel, Principal of Agoura Hills High School, spoke about the new 2005-2006 class schedule which includes the addition of two morning periods beginning with a "0" period at 7:00 a.m. and an optional "Support" period at 7:50 a.m. The new schedule offers opportunities for students to flex their class schedules and/or receive academic support from their teachers. The traditional class schedule begins at 8:40 a.m.

Councilmember Edelston reported that he attended a Los Angeles County Fire Department meeting; announced that Fire Station No. 89 is scheduled to open in August; and indicated that the relocation of the paramedic unit from Fire Station No. 65 to Fire Station No. 89 will reduce the response time for Agoura Hills residents by over two minutes.
