Section 61008. – Appeals.

"...in accordance with sections **96**822 through **96**827 of Chapter 8 of Article VI..."

City Attorney Lee recommended language for the following amendments:

61002. – Application.

1. "Written verification that there are no <u>affordability</u> covenants or other <u>affordability</u> deed restrictions on the property that prohibit or limit the use of the dwelling unit as a short-term rental, <u>including but not limited to</u> (e.g., affordable housing regulatory agreements <u>and</u> accessory dwelling unit covenants, etc.)."

## 61004. - Operating Requirements

- E. "Rental Term. Each rental term shall be no less than two three consecutive nights."
- H. "Code of Conduct. Prior to each rental the operator shall provide each guest with a code of conduct with applicable rules and regulations set forth in the Agoura Hills Municipal Code in a form approved by the City Manager. which includes occupancy limits, trash cleanup policies, parking requirements, noise limits, and a notice of potential financial penalties for violations of the code of conduct. The code of conduct shall also be posted on the inside of the main entrance door to the short-term rental, or on the wall adjacent to the door. The phone number of the local contact person shall also be provided in the same location as the code of conduct."

and the addition of a new section:

N. "All outdoor lighting that is not shielded and downward facing shall be turned off during the quiet hours period."

61008. – Appeals.

"Any person dissatisfied with a decision of the director to approve, deny, or condition a short-term rental business license application may appeal the decision to the city appeal officer by filing with the city clerk an appeal petition within fifteen days of the date of mailing of the decision. Appeals shall be submitted and processed in accordance with sections 96822 through 96827 of Chapter 8 of Article VI of the Agoura Hills Municipal Code. While the appeals process is pending, the applicant, owner, and any operator are prohibited from the short-term rental of property and the short-term rental permit at issue shall not be valid."

Mayor Pro Tem Buckley Weber moved to waive full reading and introduce **Ordinance No. 23-467**, with amendments to sections 61002(I), 61004(E), 61004(H), and 61008, and the addition of section 61004(N). Councilmember Lopez seconded. The motion carried 5-0, by the following roll call vote:
