Any inperson attendees in the conference room will be required to follow the current State and County public health guidelines. Please silence all cell phones and other electronic devices during the meeting.

However, the public may participate by providing live public comment at the meeting via Zoom (see below).
- 2. If attending the meeting virtually, live public comments may be received via Zoom (audio only) During the meeting, there will be an opportunity for the public to speak. Public testimony is limited to three (3) minutes per speaker; a speaker's time may not be transferred to another speaker. To provide public comment live at the meeting, access the meeting remotely via Zoom (see link above). To request to speak during public comment, please click the "Raise Hand" button on the Zoom toolbar. Speaker must be present when called to speak; staff will announce the speaker's name, as listed on Zoom, and unmute the
