The Agoura Hills City Council and City staff will be participating in this meeting in-person in the Council Chambers and the meeting will be broadcast to the public via remote video conferencing. Members of the public will have the opportunity to participate in-person in the Council Chambers or electronically via Zoom. Refer to "Public Participation" below.

NOTICE IS HEREBY GIVEN that the Agoura Hills City Council has scheduled a Public Hearing for the purpose of taking testimony related to consideration and potential adoption of Interim Urgency Ordinance No. 23-469U, to extend Interim Urgency Ordinance No. 23-468U re-establishing and temporarily continuing a Temporary Outdoor Operations Permit program to allow only a restaurant, gym, or fitness establishment ("Designated Establishment") to temporarily provide their services outside within the private parking lot, private sidewalk, and/or other private outdoor space located immediately adjacent to the building in which the Designated Establishment is already located, subject to the terms and conditions of a valid Temporary Outdoor Operations Permit issued by the City, any related conditions of approval, and the Interim Urgency Ordinance and making a finding of exemption under the California Environmental Quality Act. Government Code Section 65858 allows the City Council to initially extend the Interim Urgency Ordinance for 10 months and 15 days.

To provide public comment live at the meeting, access the meeting remotely via Zoom (refer to the link located on the agenda). To request to speak during public comment, please click the "Raise Hand" button on the Zoom toolbar. Speaker must be present when called to speak; staff will announce the speaker's name, as listed on Zoom, and unmute the microphone to speak (audio only). Prior to speaking, state first and last name and provide city of residence for the record. Public testimony is limited to three (3) minutes per speaker.
