Mayor Lopez made the following announcement: "We'll now begin the interview process. As mentioned at the beginning of the meeting, all applicants will remain seated in the adjacent room until their name is called for an interview. A list of the 15 applicant names is on the Council Chambers screen. The City Clerk will announce each applicant name as it is dropped into the bowl. Names will be randomly drawn, one-by-one, for applicant interviews. The City Clerk will start by drawing two names. Staff will summon the first applicant to the Council Chambers and the next applicant will be placed in the queue. Each applicant will have three minutes to make their opening statement followed by ten minutes for the City Council to ask a series of questions. When the interview is complete, the applicant will return to the adjacent room. The City Clerk will continue to draw names until all applicants have been interviewed. If a name is called and an applicant is not present, the name or names will be set aside and called after the last name is drawn from the bowl. I will now defer to the City Clerk."

City Clerk Rodrigues announced that prior to the meeting, prospective applicant, Aymeric Andrieu-Delille, had submitted a written request to withdraw and was removed from the interview process.

Based on the process above, City Clerk Rodrigues announced all applicant names, as they were initially dropped into the bowl, and, one-by-one, randomly drew and announced the name of each applicant (including the name of the next applicant who was placed in the queue) who were individually interviewed by the City Council in the following order:

### The City Council recessed at 8:53 p.m. and reconvened at 9:07 p.m.

Following the break, Mayor Lopez invited the applicants to join the City Council in the Council Chambers.

Assistant City Manager Adeva provided the next steps in the process and deferred to City Clerk Rodrigues.

City Clerk Rodrigues called upon each Councilmember to provide the name of their top applicant and received the following nominations:

- Councilmember Buckley Weber selected Penelope Sylvester;
- Councilmember Weber selected Penelope Sylvester;
- Mayor Pro Tem Anstead selected Murtaza Mogri; and
- Mayor Lopez selected Penelope Sylvester.

As there was majority support to appoint applicant, Penelope Sylvester, no further ranking from the City Council was required.

Following discussion, Councilmember Buckley Weber moved to select Penelope Sylvester to be appointed to fill the vacancy on the City Council; adopt **Resolution No. 22-2020**, with the selected appointee's name, Penelope Sylvester, inserted; and, confirm the oath of office for the appointee will be administered at the beginning of the next regularly scheduled meeting of the City Council on September 28, 2022, allowing the newly sworn Member of the City Council to be seated at the dais at that time and participate in the remaining items of the Agenda that evening. Councilmember Weber seconded. The motion carried 4-0, by the following roll call vote:

The City Council thanked all applicants for their participation in the process and congratulated Penelope Sylvester on her appointment to fill the vacancy on the City Council.

Councilmember Buckley Weber encouraged applicants to consider applying for other boards and commissions with the City or volunteer for upcoming City events.

# **COUNCIL, STAFF COMMENTS**

Deputy City Manager Celaya announced that September is National Preparedness Month and Saturday, September 24, 2023, from 9:00 a.m. to 1:00 p.m., in the Community Room, staff would be hosting "Emergency Preparedness Saturday" to provide emergency information, including wildfire and earthquake preparedness and sidewalk CPR, and residents would have the opportunity to sign-up for the various alert notification programs offered through the City and County.

Director of Community Services Brink announced Reyes Adobe Days will be held October 7-9, 2023, and the City is seeking volunteers to assist with the event and provided information to sign-up with the Community Services Department.

Mayor Lopez spoke about Carter Brian Stone, a 15 year-old freshman offensive lineman on the Agoura High School Junior Varsity Football Team, who attended his first day of school on August 24, 2022, and the following day went in for routine surgery for a shoulder injury when doctors discovered an undiagnosed tumor on his heart, from T-cell leukemia and, tragically, he was pronounced deceased after being emergency airlifted to Children's Hospital in Los Angeles. The day after his death, the Agoura High School Chargers played their second game of the year (21-7 against Ventura) and honored Carter by holding a moment of silence. They also wore his number (76) and the phrase "Be Like Carter" on their helmets and will continue to do so through the remainder of the season. Carter was known as the kind of kid who went the extra mile, he had a charming sense of humor, love of football and music, was incredibly kind and compassionate, and loved spending time with his family. At 15, he was just beginning to grow into the remarkable person he was becoming and will be truly missed by many. On behalf of the City Council and staff, Mayor Lopez extended sincere condolences to Carter's parents, Brian and Danielle Stone, and their entire family, and respectfully requested the meeting be adjourned in memory of Carter Brian Stone.
