Councilmember Wolf recused himself from participation on this item, as he resided in the Annandale complex, stepped down from the Council dais, and exited the Council Chambers at 6:22 p.m.

Following presentation of the staff report, Mayor Anstead opened the floor for public comments.

There were no public comments.

ACTION: Following discussion, Councilmember Sylvester moved to approve

Waste Management's proposed valet rate increase request and direct Waster Management to notify the affected customers. Councilmember Lopez seconded. The motion carried 4-0, by the

Councilmember Wolf rejoined the meeting at 6:53 p.m.

COUNCIL, STAFF COMMENTS

Councilmember Sylvester commended everyone on Community Service Day and inquired how much the City saved by (the volunteers) painting the railing at the Recreation and Event Center. Community Services Director Brink responded upwards of \$20,000-\$25,000 was saved.

Mayor Pro Tem Buckley Weber expressed her sadness over the last week and a half and shared her concerns regarding all the violence and prejudice occurring daily; assured residents that the City is doing things, such as working with Captain Seetou at the Lost Hills Sheriff's Station on the startup of an interfaith security group for places of worship, the City presented a proclamation to the Chabad of the Conejo (and the Jewish Federation of Greater Los Angeles) denouncing antisemitism, and the City/COG (Council of Governments) has a homeless coordinator who works with (the region's) unhoused

individuals; and invited the community to forward their suggestions to her to promote love and peace for the City to "see if there's anything else that we can do to work towards making it a better community and a better world."

Councilmember Sylvester spoke about the recent passing of former Willow Elementary School Principal, Brent Noyes, and read the following personal tribute aloud: "I would like to adjourn tonight's meeting in memory of Brent Noyes. Brent and I both arrived at Willow Elementary School in 1998. He was the Principal; I was an incoming parent. We worked closely together while I was a PFA President at the school and I will always be grateful for his leadership, sympathy, and support. He really loved his pupils and enthusiastically participated in our school's birthdays. Who can forget him performing the Chicken Dance at our morning assemblies? His name will always bring a smile to my face." Councilmember Lopez added: "He also moved over to Yerba Buena when I was on the Parent Faculty Club and the kids did get a kick out of his last name, was Noyes, but they always called him No-Yes."

Councilmember Lopez spoke about the recent passing of Westlake High School freshman, Wesley Welling, and read the following tribute aloud: "As you see, we, the Agoura Hills City Council, we will sometimes close our meetings in honor and memory of the life of a community member and we don't do this for everyone. We do this to highlight those who have often spent many years giving back to our community and making an impact and making a difference right here at home in our own community. And, so, it's particularly heartbreaking to adjourn in memory of someone who has done all that, but in only 15 short years of life. Wesley Welling, a freshman at Westlake High School was tragically killed on April 18, caught up in a series of crimes committed across the region by a suspect. While he was waiting for the bus, he was struck down in front of his sister, in front of his friends, and in front of his classmates and this tragedy occurred only a week after the passing of Wesley's Aunt, his Mom's sister, so, you can imagine the unbearable grief that this family, in our own community, is experiencing. So, Wesley and I did not know each other, but I know that our paths had surely crossed. From the time he was a small child, Wesley and his family were frequent volunteers at the Conejo Meal and Shelter Program, where I had volunteered for many years with his Uncle, Beau Morris, and, I've included a picture here on our screen of Wesley years ago with his siblings and his Uncle Beau at one of the shelter locations. Also, there's a picture him, a little bit older, with his Uncle Beau and, then, the picture of him and his Mom, is just so beautiful, and I think all of us who are mothers can see the look in her eyes looking at her son and really feel the love and the loss. In the spirit of giving back to the community was instilled within Wesley by his caring and generous family from a very young age. And, Wesley was not only a giving young man, but he has been described as kind, calm, playful, amazing, positive, and a wonderful son, brother, and friend who touched the lives of those around him. This Saturday, at 10:00 a.m. at Calvary Church in Westlake, there will be a memorial service for Wesley. Those who knew him well, his family, his classmates, his teachers, and others will surely be there to share stories of Wesley's life – a life that was cut short way too soon, and, so, I encourage the community to attend. Residents from Agoura Hills, the Conejo Valley, and beyond, have rallied around Wesley's family raising funds to assist them, via a GoFundMe campaign, holding vigils at schools, churches, and businesses around town, and coming out in numbers to show support for this family in mourning. And,

so, I respectfully request that we adjourn in memory of Wesley Welling, so that their family knows that we, too, the City of Agoura Hills, send our deepest condolences."

Mayor Anstead thanked all the staff and volunteers who participated in Community Service Day.
