CONTRACT AWARD FISCAL YEAR 2023-2024 PAVEMENT

REHABILITATION PROJECT; NIB 23-01

On March 22, 2023, the City Council authorized staff to seek bids for the Fiscal Year 2023-2024 Pavement Rehabilitation Project; NIB 23-01 (Project). The project includes, but is not limited to the following: crack sealing, localized aggregate base and pavement repair, minor concrete repairs at City Hall parking lot, and pavement maintenance with slurry seal including City Hall and Recreation and Event Center Parking Lots.

The City of Agoura Hills (City) Pavement Rehabilitation Program is an annual Capital Improvement Project (CIP) identified in the City's adopted 5-Year CIP. Streets are programmed as either overlay resurfacing or slurry seal work, which are designed to extend the service life of the roadway, as a cost-effective approach, and allow the City to resurface more lane miles of pavement. Streets designated for slurry seal receive localized pavement repairs, crack seal, and slurry seal as a new surface-wearing course.

On April 27, 2023, the City received five (5) electronic bids. Of the five (5) bids submitted, four (4) were responsive and one (1) was unresponsive. The one (1) unresponsive bid, did not complete the required bid items form.

The responsive bid results are as follows:

Staff reviewed the bid of the apparent low bidder, Mission Paving and Sealing, Inc., and deemed their bid responsive and acceptable. Mission Paving and Sealing, Inc. provided references to similar projects from other public agencies and all were in good standing.

The Project is budgeted at \$655,000 in the proposed Fiscal Year 2023-24 Budget. The funding sources for the Project includes \$490,000 of Road Rehabilitation Funds (SB1) and \$165,000 of General Funds for the City Hall and Recreation and Event Center Parking Lots.

The project is expected to start construction in the streets in the middle of July, the parking lots at end of August, and the work will take approximately 45 days to complete.

RECOMMENDATION

Staff respectfully recommends the City Council:

- 1. Award the contract for the Fiscal Year 2023-2024 Pavement Rehabilitation Project; NIB 23-01, to Mission Paving and Sealing, Inc., in the amount of \$570,281.00;
- 2. Authorize the City Engineer to issue necessary change orders within a 15% contingency;
- 3. Authorize the Mayor to sign the contract agreement on behalf of the City Council.
