**RECOMMENDATION**: Staff recommends the Planning Commission approve a

resolution, recommending City Council adopt an Ordinance amending provisions to the outdoor dining design and operational standards and amending provisions related to off-street parking based on the

findings of the draft Resolution.

"B. The proposed amendments to the Parking Allocation section include:

1. Amending Section 9654.6 (Parking Allocation);

The second section of the AHMC that is proposed to be amended is Section 9654.6, the Parking Allocation table. The proposed

amendment would include a change to the existing parking requirement for restaurants from 15 spaces per 1,000 square feet of seating and waiting area to the International Transportation Engineers (ITE) standard which is an average of 9.6 seats spaces per 1,000 square feet of gross floor area."

Following presentation of the staff report, Chair Asuncion opened the Public Hearing at 6:58 p.m.
