"I'd like to request a correction to the minutes for Item No. 1 on the Consent Calendar. At the June 28, Regular City Council Meeting, under Intergovernmental, Special Purpose Committee, & Departmental Reports, I reported out on the action that was taken at the Environmental Policy Committee meeting for CalCities regarding AB 460 and AB 1337. To clarify the vote that occurred, I would like to make a correction to the minutes on Item No. 1, Page 2, and strike out the third paragraph in its entirety and replace with the following paragraph, which I will read as follows:

Mayor Pro Tem Buckley Weber reported that she attended the first inperson meeting of the Environmental Policy Committee for CalCities in June and the Committee was asked by CalCities to take a position on AB 460 City Council Regular Meeting Minutes In-Person Meeting and Video Conference (Zoom) Wednesday, July 12, 2023 Page 3

and AB 1337. As the Vice Chair of the Committee, and, as both of these bills would take away local control and give control to the State Water Resources Board, she reached out to, and received guidance from City staff regarding her ability to vote pursuant to the City's legislative platform. Although the Environmental Policy Committee for CalCities approved supporting AB 460, she voted against it. With regards to AB 1337, Mayor Pro Tem Buckley Weber joined the Committee in taking a neutral position on AB 1337.
