The City Council recognized Assemblymember Richard Bloom for his support of the City's Linear Park Project.

In celebration of the City of Agoura Hills 40<sup>th</sup> Anniversary – 40 Facts for 40 Years, Mayor Lopez presented the following fact about Agoura Hills: 1) prior to the City's current rectangular logo of rolling hills and an oak leaf, the original City seal was a circle split into four quadrants that each contained a landmark that embodied Agoura Hills and included an Oak tree, a Chumash Native American symbol, the Reyes Adobe, and Ladyface Mountain. The perimeter of the circle contained the text: "City of Agoura Hills, CA" and the incorporation date of "December 8, 1982," and was outlined in leaves. The current City logo is displayed on the wall behind the City Council dais; a model of the former City seal is displayed in City Hall in the hallway near the City Council's office. Mayor Lopez also shared that she acquired one of the original City pins from a former City Planner.

City Attorney Lee provided the following proposed amendment to <u>Ordinance No.</u> <u>22-461</u>, Section 9663.6 (F)(5), and inquired if the City Council wished to include all landscape plantings or to set a numeric threshold.

"Landscape Pplantings under an oak tree canopy shall consist of native, droughttolerant species selected from those listed by the California Native Plant Society in the Calscape website specific to Agoura Hills."

MOTION: Councilmember Northrup proposed 75 percent and to incorporate

that into her motion. Councilmember Buckley Weber seconded.

Councilmember Buckley Weber seconded. The motion carried 4-1, by the following roll call vote:
