SUBJECT: DISCUSSION REGARDING STATE WATER RESOURCES CONTROL

BOARD DRAFT REGULATIONS

The purpose of this report is to present the City Council with information regarding draft regulation language currently being considered by the State Water Resources Control Board (SWRCB). These regulations have been written as a means to implement the 2018 Executive Order by Governor Brown "Making Conservation a California Way of Life".

The City has a strong history of supporting legislature that protects our natural resources. and water conservation has been thoughtfully adopted in the City's policies and programs. Unfortunately, the draft regulations are written in granular detail that may not fit all California cities, and may have unknowable consequences and implications throughout These laws would be imposed on water districts throughout California. including our own, Las Virgenes Municipal Water District (LVMWD). LVMWD's Resource Conservation Manager, Craig Jones, will present the draft regulations, and express the concerns LVMWD has raised in conjunction with other members of the Association of California Water Agencies (ACWA).

Staff has prepared and attached a letter for the City Council's consideration, urging the SWRCB to take the additional time necessary to address the ACWA comments and allow the implications of the regulations to be more understandable. The SWRCB will be accepting written comments through October 17, 2023. Should the City Council determine that comments should be sent, a recommendation authorizing Mayor Anstead to sign the attached letter is written below.

RECOMMENDATION

Staff respectfully recommends the City Council authorize the Mayor to sign the attached comment letter to the State Water Resources Control Board on behalf of the City Council.
