COUNCIL, STAFF COMMENTS

Mayor Anstead read a tribute honoring Ellen Louise Wohl, a vibrant member of the community who passed away last week, and requested the City Council adjourn the meeting in her memory.

The City Council shared their personal remarks and tributes regarding Ellen Louise Wohl as follows:

- Mayor Pro Tem Buckley Weber shared that she was not prepared to properly acknowledge Ellen this evening and would share (her comments) another time, noting that she had attended the funeral and that she *"was a fabulous woman, a very important volunteer for this City."*
- Councilmember Lopez shared her personal remarks, noting that Ellen had been a neighbor, and that *"we should all serve our community in the same heart of service that Ellen had."*

Councilmember Sylvester thanked staff for a successful Reyes Adobe Days.

The City Council shared their personal remarks regarding Israel as follows:

- Mayor Pro Tem Buckley Weber read a personal statement that she stands with Israel and encouraged everyone to join her in *"standing against evil and standing up for the goodness of humanity."*
- Councilmember Wolf asserted that he stands with Israel and read a personal statement, noting that the City had formerly issued a proclamation denouncing antisemitism and supports and stands with its residents.
- Councilmember Lopez shared her personal remarks, professed her support for Israel, and noted that if anyone in the community had any situation that they need help with in Israel, "we can help you connect with Congressman Julia Brownley's office."
- Councilmember Sylvester stated that she felt everyone around the world was standing with Israel.

• Mayor Anstead echoed the City Council's remarks and stated that he also stands with Israel and requested the meeting be adjourned in memory of the victims in Israel and in memory of Ellen Wohl.
