SUBJECT: DISCUSSION REGARDING COMMERCIAL CANNABIS SURVEY

On June 28, 2023, the City Council approved Resolution No. 23-2040 adopting citywide goals for Fiscal Years 2023-24 and 2024-25. One goal established by the City Council was to complete a public outreach process on the possibility of allowing commercial cannabis uses in the City. The first step in that process is developing a public survey to gauge residents' opinions on the allowance of certain uses related to commercial cannabis, including retail sales, distribution, manufacturing, research and development, and testing.

On August 24, 2023, the City entered into a contract with Probolsky Research (Consultant) to begin drafting a community survey. After the draft survey was completed, staff and the Consultant attended two Land Use/Economic Development Subcommittee (LUEDC) meetings in October to receive feedback prior to presenting the survey to the City Council. The survey has been revised to address comments made at the LUEDC meetings, and staff hopes to receive feedback from the City Council prior to initiating the survey. Attached you will find a copy of the full survey questionnaire.

FISCAL IMPACT

There is no additional fiscal impact to the City Council 2023-24 adopted budget as funds were appropriated for this project in the Community Development Department's Contract Services Account, 010-4305-5520.

RECOMMENDATION

Staff respectfully recommends the City Council review the survey questionnaire, provide staff with feedback, and direct staff to survey the community.
