21. Delete Condition No. 21 (Duplicative)

The Covenants, Conditions and Restriction (CC&Rs) shall ensure, among other things, common ingress, and egress, joint maintenance of all common access parking areas, utilities, and drives, as applicable.

- 25. Prior to final map recordation, applicant shall provide a copy of proposed Covenants, Conditions and Restrictions (CC&Rs), as applicable to the project, to the City Engineer for review and approval of the City Attorney. These CC&Rs shall ensure, among other things, common ingress and egress, joint maintenance of all <u>landscaping</u> and common areas, <u>including without limitation</u>, access parking areas, utilities and drives, as applicable to the project.
- 31. Applicant shall install irrigation and landscape within the parkway on the south side of Canwood Street fronting this project to the satisfaction of the City Engineer in accordance with the original development agreement between the developer and the City of Agoura Hills Site Plan and Conditional Use Permit No. 84-CUP-002 for the development of the Mediterranea II Office Building.

Following the presentation, and a question and answer period of staff, Chair Asuncion asked for Commissioners to disclose any ex parte communications.

Chair Asuncion disclosed that he drove by the project.
