As a resident of Agoura Hills since 2012, I have enjoyed the peace and ease that living here provides. I sleep easily knowing I'm in a safe community. I drive easily to the freeway and my local shops. I love the peace and quiet of our small community.

The COVID-19 shutdown was not easy on this community. But, we followed the protocols to keep ourselves and our neighbors safe. Our outside time was precious. Yet, we had the courtesy to cross the street or stand at least six feet away to make sure others were safe.

This cannot be said for Cronies Agoura Hills. Cronies had two restaurants at the time (and may still have two). They shut down their Newbury Park location in accordance with COVID protocols, but kept open the Agoura Hills location. A tent was placed in the parking lot in front the restaurant and customers were free to sit, and eat and drink, shoulder to shoulder.

I am a member of the Agoura Hills community, and I disagree with the way cronies has handled their business over the past handful of years. I have been a close neighbor of this establishment since May 2020 (and a member of this community since the 90s) and have seen how they handled themselves during the Covid lockdown and more.

Unfortunately, they do not represent a sense of community and safety that Agoura prides itself on.
