This was my comment for the CUP -2023 - 0026

Cronies violated health codes and mandates during the peak of the Covid pandemic. Attracted crowds of people to our community which put residents and employees of near by businesses at high risk for covid infections.

My teenage sister was working at the Goodwill next to Cronies during this time and she was dealing with customers from Cronies acting belligerent and refusing to put on a mask when they came into the store. She was just doing her job but it was so much more difficult when Cronies brought the circus to town.

What other businesses in town is open until 1 am besides the canyon club (occasionally) and Yum Yum donuts? Do we want or need a place selling hard liquor after midnight when there are residential homes less than 200ft behind the restaurant?
