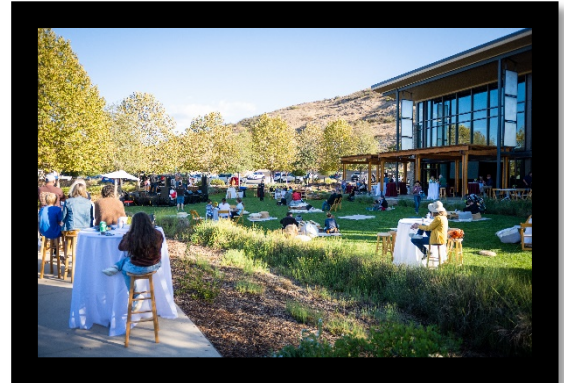

#### **Why work for the City of Agoura Hills?**

When you become part of the City of Agoura Hills family, you will work alongside a team of dedicated, skilled and highly motivated professionals, who contribute their talents and commitment in providing excellent services to our community. Here is an outstanding opportunity to join a dynamic organization dedicated to serving the Agoura Hills community.

#### **What You'll Do**

Depending upon assignment, duties may include, but are not limited to the following:

- Working hours will vary. Applicant must be available during normal business hours during the week, AND applicant must be available to work nights, weekends, and holidays. No set schedules can be provided.
- Instruct and facilitate recreational classes.
- Organize, direct and participate in the assigned recreation program; develop participant interest and enthusiasm. Assist in the encouragement of participation and good sportsmanship.
- Monitor Recreation Center; scorekeeper for recreational sports leagues.
- Assist department staff in the direction or execution of other recreation programs and special events.
- Prepare the recreational facility for program activities; direct the use and care of recreational equipment and facilities.
- Collect program registrations and fees; prepare records and activity reports in accordance with established procedure.
- Participate in program publicity and promotional activities.

#### **What You Bring**

Applicant must be a high school graduate or equivalent. Must be 18 years of age and possess six months and/or 500 hours of group recreational activity leadership experience, or any combination of education and/or experience that has provided the knowledge, skills, and abilities necessary for satisfactory job performance. Completion of one year of college-level course work in a recreation or related field is desirable, but not required.

Working knowledge of the basic rules and regulations governing competitive group athletic games and sporting events; objectives and practices common to group recreational and social activities. Ability to organize and direct individuals and groups, and conduct and participate in recreational and social activities, and special events; adhere to program standards and objectives; maintain records and simple reports; meet with the public in situations requiring diplomacy and tact; communicate effectively both orally and in writing; set up equipment and prepare recreation facility for programs; understand and follow verbal and written directions; establish and maintain cooperative working relationships.

Possession of a valid California Class C driver's license at the time of hire and have a satisfactory driving record based upon specific program needs. Possession of or ability to obtain American Red Cross certificates in first aid and CPR within six (6) months.

### Physical Demands

While performing the duties of this class the employee is regularly required to stand, climb and perform other movements requiring physical agility. Employee must be able to exert sufficient force to lift, carry, push, pull, or otherwise move objects, carry tables, chairs, boxes, and bags. Physical demands include prolonged sitting, standing, walking, reaching, twisting, turning, kneeling, bending, squatting and stooping in the performance of daily activities. Physical demands may require frequent lifting of objects up to 50 pounds, often combined with bending and twisting. Employee must be able to talk or hear, both in person or on the telephone, and operate standard office equipment. Specific vision abilities required by the job include close vision, color vision and the ability to focus.

### Mental Demands

While performing the duties of the class, the employee is regularly required to effectively use written and oral communication skills; observe and interpret situations; read and interpret data, information and documents; interact with City staff and other organizations; and deal with customer relations.



### Work Environment

The employee works in both typical office conditions and in outdoor recreational settings. The noise level of the office work environment is usually quiet. However, the environment for indoor and outdoor recreational settings is dependent upon site location, type of activity being performed, and weather conditions. The noise level for indoor and outdoor recreational setting is frequently loud. The employee may work outdoors in all weather conditions including wet, hot, cold and may be exposed to heavy dust and pollen. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

### **The Fine Print**

Prior to hire, candidates will be required to successfully complete a pre-employment process, including employment verification, reference checks, completion of a criminal history questionnaire and Department of Justice (DOJ) and Federal Bureau of Investigation (FBI) fingerprint check and negative result from a tuberculosis test. A conviction history will not necessarily disqualify an applicant from appointment; however, failure to disclose a conviction will result in disqualification from the recruitment process. All offers of employment with the City are made contingent upon receipt of written proof of legal right to work in the United States in accordance with the Immigration Reform & Control Act of 1986.

The provisions of this bulletin do not constitute a contract, expressed or implied, and the City may modify or revoke any provisions contained in this bulletin without notice.

The City provides employment rights and non-discrimination on the basis of disability, as established in the Americans with Disabilities Act of 1990.
