1. Can you share what the BIDS were that were rejected from the last round and who the listed subs were?

Answer: Rejected at the July 10th City Council meeting, two (2) contractors – no subs Cinbad - \$164k deemed non-responsive due to NO Bidders Bond received and Zuma Construction - \$338,717 which exceeded the available budget

2 In the process of applying a BID to #24-04 in the Planet Bids Portal and there is an old rejected bid for the project. How can I apply to that project?

3 Who is the restroom manufacturer? Is there a spec sheet for the restroom unit that will be installed?

4. Can we assume both projects (this and the Chumash Park ADA Improvements) will be happening concurrently? For example, regarding the concrete that needs to be removed to trench for the utilities, can we assume the Contractor for the ADA project will remove it, as it's part of their scope?

Answer: They will be concurrently, but the utilities trench is for THIS phase, you do not have to worry about replacing the concrete as the concrete will come at the very end of completion

5. Are we responsible for erecting a temporary fence, or can we assume it will be up as part of the other contract?

Answer: Yes, this is a part of Mobilization located in Section 1, pgs. SP4-SP6

6. Can the Contractor use park water, from a quick coupler for example, during the course of construction?
