#### **CONTINUED DE NOVO PUBLIC HEARING / APPEAL**

10. Conduct a Continued De Novo Public Hearing to Consider an Appeal of the Planning Commission's Denial of Conditional Use Permit Number CUP-2023-0026, a Request for a Type-47 Alcohol License to Allow the Sale of Distilled Spirits, Wine, and Beer (*Continued from May 22, 2024*)

Mayor Buckley Weber deferred to Councilmember Anstead.

Councilmember Anstead made the following announcement: *"I received a contribution for my political campaign in the past 12 months from one of the owners of the Applicant in the next proceeding that amounted to over \$250, as such, I will* 

*be recusing myself from this item based on California law*" stepped down from the Council dais, and exited the Council Chambers at 6:19 p.m.

Mayor opened the Public Hearing at 6:20 p.m. and deferred to City Attorney Lee.

City Attorney Lee made the following announcement: "Thank you, Mayor, Good evening Honorable Mayor and members of the City Council, I thought it would be helpful to provide a summary of the framework of the proceedings this evening to assist both the Council and the members of the public, as well as the Applicant, to give an idea of what to expect this evening. First, the City Council will be holding a continued "De Novo" Public Hearing on CUP-2023-0026. In the City of Agoura Hills, all appeals of Planning Commission decisions are heard "De Novo" at the City Council level. A "De Novo" land use hearing is a completely new hearing where the City Council takes a fresh look at the project and is not limited to the issues raised in the appeal application. This allows the Council to look at all components of the project and make a decision on the project as a whole. The Council need not to give particular weight or deference to what the Planning Commission decided. Now, you can consider what the Planning Commission decided, certainly, the City Council is not bound to follow Planning Commission's decision. Next, I'd like to summarize the order of the proceedings for the hearing this evening. So, first, the Mayor has opened the Public Hearing already, thank you. Next, we will be having the staff report and then, City Council disclosure of ex parte communications. As this is a quasi-judicial matter, if Councilmembers have received relevant information about this matter outside the Public Hearing, they should publicly announce this information obtained before testimony begins. Next, we will have City Council guestions of staff. At this time, the Council should avoid commenting on the project or deliberating. Please, just stick to questions of staff. Next, we will move to the Applicant/Appellant's presentation; they will have 15 minutes and then the Council will have opportunity to ask the Appellant questions. Then, we will move to public comment portion of the Public Hearing. Each public speaker will have three minutes and the Council may also ask the public questions, as necessary. Then, we will move to Applicant's rebuttal and they will get five minutes for rebuttal. Then, we will have last call for Council questions and the Council should conclude their questions prior to the close of the Public Hearing. Then, the Mayor will close the Public Hearing and then we will have Council discussion and deliberation. And, during deliberation it would be appropriate for the Council to explain why they can or cannot make findings required for the approval of the project so that staff can prepare the appropriate resolution of approval or denial based on Council's direction. And, that concludes my summary. Thank you Mayor."

Following presentation of the staff report, Mayor Buckley Weber inquired if any Councilmember had any ex parte communications to disclose.

- Mayor Pro Tem Sylvester disclosed that she had met with City staff and watched the Planning Commission meetings.
- Councilmember Klein Lopez disclosed that she had met with City staff and watched the Planning Commission meetings.

- Councilmember Wolf disclosed that "on July 8, 2024, at 12:00 p.m., I spoke with Matt Guthrie who told me he was helping with the appeal and he had first reached out to me on email, he reached out to see if I had any questions. I didn't have any questions, we discussed hours for about five minutes and that was the duration of the call."
- Mayor Buckley Weber disclosed she had watched the Planning Commission meetings and had received an email from Matt Guthrie on behalf of Cronies, but had not met or communicated by email.

Following a question and answer period with staff, Mayor Pro Tem Buckley Weber opened the floor for public testimony from the Applicant/Appellant.

There being no public comments, or further questions of staff or the Applicant/Appellant by the City Council, Mayor Buckley Weber closed the Public Hearing at 7:51 p.m.

During deliberations, the City Council did not reach consensus. Following further discussion, Mayor Buckley Weber reopened the Public Hearing at 8:16 p.m. to ask further questions of the Applicant/Appellant.

**The City Council recessed at 8:29 p.m.,** to afford the Applicant/Appellant the opportunity to discuss whether or not they wished to consider a continuance of the public hearing and/or a reduction of the hours of operation. City Attorney Lee suggested the Councilmembers leave the dais one at a time.

# Mayor Buckley Weber reconvened the meeting at 8:41 p.m. and announced the Public Hearing was open.

Following further discussion regarding the reduction of the hours of operation and the Applicant/Appellant agreeing to the hours of 8:00 a.m. to 10:00 p.m., seven days a week, Mayor Buckley Weber inquired if Councilmember Klein Lopez could now make the findings with the change in the hours.

Councilmember Klein Lopez stated: "for the Municipal Code Sections that I read, is really, as you mentioned 41-47, even taking out the high crime disproportionate number, if we decided to do that, I would still not be able to make the findings on the first six which was: compatible with surrounding properties, noise louder than ambient level, increased vehicular pedestrian traffic detrimental to public health and safety welfare, harmful secondary nuisances school or similar use buffered by topographical conditions, and beverage sales restricted to be compatible with quiet enjoyment of the neighborhood and I can always withdraw my, for now, or we can discuss it if we continue it, the disproportionate number of police calls. I still would not be able to make those first findings because of my concerns with 41-47."

Mayor Buckley Weber stated: "I can make the findings with the change of the hours from 8:00 (a.m.) to 10:00 (p.m.), seven days a week, because my biggest concern, everything stemmed from the late night hours, and if Cronies really is not going to stay open past 10:00 (p.m.), I am more comfortable and can make those findings."

Mayor Buckley Weber closed the Public Hearing at 8:46 p.m.

Mayor Buckley Weber called for a motion and second "to approve the project, that all the old conditions of approval will apply and the only change in the conditions of approval would be that the hours would now be 8:00 a.m. to 10:00 p.m., seven days a week, and we would instruct staff to come back with a resolution of approval with those new hours."

- ACTION: Mayor Pro Tem Sylvester moved to "approve the upgrade to Permit 47 with the condition that the hours are now changed from 8:00 a.m. to 10:00 p.m., seven days a week, and direct staff to bring back a resolution (approving the project) at the August 14, 2024, meeting". Councilmember Wolf seconded. The motion carried 3-1, by the following roll call vote:
  - AYES: Mayor Buckley Weber, Mayor Pro Tem Sylvester, and Councilmember Wolf.
