LOCATION: 5619 Slicers Circle (A.P.N. 2054-018-132)

REQUEST: Request for approval of a Site Plan/Architectural Review

to construct a 65 square-foot, first-floor addition, a 1,645 square-foot, second-story addition and a 117 square-foot balcony to an existing 1,670 square-foot, single-story, single-family residence; and a Variance request to provide a 9.83 foot combined side yard setback instead of the minimum 14 feet, and a 14.5 foot rear yard setback

instead of the minimum 15 feet.
