*(a)* Except as permitted by Article 1, Section 4, of the California Constitution, no Responsible Person shall conduct, permit, allow or host an unruly gathering at his or her place of residence or other private property or host a gathering at a public place under his or her control. where two or more underage persons are present, and where the gathering is an unruly gathering and alcoholic beverages are being consumed by, served to or in the possession of any underage person.
