REQUEST:	Request for recommendation to the City Council to amend Zoning Ordinance Sections 9120.9.I and 9312.2.I to define and allow for internet cafes as a permitted use, and to define and allow internet arcades as a permitted use subject to a Conditional Use Permit.
RECOMMENDATION	Staff recommends that the Planning Commission adopt a motion to continue Zoning Ordinance Amendment Case No. 04-ZOA-001 to the July 15, 2004 Planning Commission Meeting.
B. APPLICANT:	Mr. Scott Mineo 79 Albion Place Newbury Park, CA 91320
CASE NO.:	01-CUP-006 and 01-VAR-005
LOCATION:	4828 Canyon Way (A.P.N. 2061-017-041)
REQUEST:	Request for approval of a Conditional Use Permit application to construct a 2,429 square foot, two-story, single-family residence and an attached 502 square foot garage on an 8,310 square foot lot. Also requested is a variance to reduce the side yard setback from 10 feet to 8.5 feet.
ENVIRONMENTAL ANALYSIS:	Categorically Exempt from CEQA, per Section 15303(a)
RECOMMENDATION	Staff recommends that the Planning Commission adopt a motion to approve Conditional Use Permit Case No. 01-CUP-006 and Variance Case No. 01-VAR-005, subject to conditions, based on the findings of the Draft Resolutions.
