REQUEST:	Request for recommendation to the City Council to amend Zoning Ordinance Sections 9120.9.I and 9312.2.I to define and allow for internet cafes as a permitted use, and to define and allow internet arcades as a permitted use subject to a Conditional Use Permit.

REQUEST:	Request for approval of a Conditional Use Permit to construct a 7,113 square-foot, two-story residence with an attached garage and a 506 square-foot non-residential studio structure; a request for a Variance from Zoning Ordinance Section 9607.1.A to exceed the maximum building height; and a request for an Oak Tree Permit to possibly encroach within the protected zone of ten (10) oak trees and to remove one (1) oak tree per the proposed construction.
ENVIRONMENTAL DETERMINATION:	Mitigated Negative Declaration
