REQUEST:	A request to amend an approved Conditional Use Permit to change the approved exterior building materials of a new hotel that is under construction.

REQUEST:	Request to amend an approved Site Plan/Architectural Review permit to change the approved colors and materials of a previously approved office building; and a request for a Variance from Zoning Ordinance Section 9383.3 to increase the height of the approved office building from 35 feet to 42.83 feet.
