Councilmember Schwarz spoke about the success of the Great Race of Agoura Hills last Saturday and commended staff on the event.

Mayor Pro Tem Weber also spoke about the Great Race and reported that he and Councilmember Koehler had participated in the Friendship Walk, sponsored by the Conejo Valley Friendship Circle, on March 30, 2008.

Councilmember Kuperberg announced the Planet Expo 2008 event, scheduled for April 19, 2008 at Sumac Park in Agoura Hills, and also announced the Relay for Life event, scheduled for May 3-4, 2008 at Willow Elementary School, and encouraged everyone's participation in the events.

Councilmember Koehler acknowledged Meredith Petit, Recreation Supervisor, for her participation in running the half marathon at the Great Race.

Mayor Edelston encouraged participation in Relay for Life, congratulated staff and Council for participating in the Presidential Challenge physical fitness program, reported his participation in the Conejo Future Foundation Youth Congress, and reminded everyone that City Council
