Following presentation of the staff report, Mayor Edelston opened the Public Hearing.

on a roll call vote 5-0.

and waive further reading of non-urgency Ordinance No. 07-350, was seconded by Mayor Pro Tem Weber, and approved on a roll call vote 5-0.

#### CITY COUNCIL DISCUSSION/ACTION

14. Consider Authorization to Manage the Malibu Creek Watershed Compliance Monitoring Program and Solicit Proposals for Professional Water Quality Monitoring Services

Following presentation of the staff report, Mayor Edelston opened the floor for public comment. There were no public speakers.

Following discussion, the motion by Councilmember Kuperberg, to authorize staff to take the lead on compliance monitoring efforts for the Malibu Creek Watershed and to solicit proposals for professional water quality monitoring services for the Malibu Creek Watershed Compliance Monitoring Plan, was seconded by Councilmember Schwarz and approved 5-0.

#### **COUNCIL, STAFF COMMENTS**

Councilmember Koehler spoke about the success of the 25<sup>th</sup> Anniversary Gala and commended staff on their vision and transformation of the Canyon Club.

Councilmember Kuperberg spoke about the proliferation of signage on the gates at Willow Elementary School and requested staff look into the issue; spoke about the success of the 25<sup>th</sup> Anniversary Gala, Reyes Adobe Days, and City Council reorganization meeting, and commended staff and City volunteers on their efforts; requested the Council's permission to adjourn in memory of Dick Crowley, a former Prisoner of War (POW) and long-time resident of Agoura Hills and City volunteer, who passed away earlier in the week, and extended condolences to his wife, Dolores Crowley.

Mayor Pro Tem Weber congratulated Mayor Edelston on his first meeting; spoke about Dick Crowley and indicated that he would be dearly missed in the community; commended staff on the Gala; and wished everyone a Happy Hanukkah, Merry Christmas, and Happy New Year.

Councilmember Kuperberg wished Mayor Pro Tem Weber an (early) happy birthday.

Councilmember Schwarz spoke about the amazing transformation of the Canyon Club for the Gala and thanked Community Services and staff for a phenomenal event; and wished everyone a safe holiday season.

Mayor Edelston echoed the Council's comments regarding the Gala and wished everyone a Happy Hanukkah, Merry Christmas, and a safe and Happy New Year.
