Councilmember Koehler suggested that, with everyone being conscious of escalating gas prices and the economy, the community take the opportunity to consider patronizing the many fine local restaurants in the area.

Councilmember Schwarz noted that, during his morning walks, he has observed a lot of water waste through runoff or broken sprinkler heads and reminded everyone to conserve water and fix their sprinkler systems.

Councilmember Koehler noted there is a free water audit service available through the Las Virgenes Municipal Water District where, by appointment, a representative will come out and evaluate water usage at a residence.

Mayor Edelston noted that he attended the Platinum Groove concert, followed by the fireworks show, last Sunday and announced the next concert in the *Summer 2008 Concerts in the Park Series* will be Chet McCracken (former drummer for the Doobie Brothers) at Chumash Park on Sunday, July 20, 2008.
