9. Consider Request to Oppose Proposition 7 - "Solar and Clean Energy Act of 2008"

Following presentation of the staff report, Mayor Edelston opened the floor for public comment.

ACTION: Following discussion, the motion by Councilmember Kuperberg, for City

Council to go on record in opposition to Proposition No. 7 and to direct staff to initiate documents to that effect, was seconded by Councilmember

Schwarz, and approved 4-0, with Mayor Pro Tem Weber absent.

10. Consider Approval of Agreement with Blackboard Connect, Inc., to Provide Mass Notification Services

Mayor Edelston noted the agreement was not available and the item would be brought back for approval at a later date.

Following presentation of the staff report, Mayor Edelston opened the floor for public comment. There were no public speakers.

### **CITY COUNCIL, STAFF COMMENTS**

Councilmember Kuperberg announced the regular City Council meeting of September 24, 2008 had been canceled to afford Council the opportunity to attend the League of California Cities 2008 Annual Conference, and the next regular meeting has been moved from Wednesday, in honor of a Jewish holiday, to Tuesday, October 7, 2008. Councilmember Kuperberg encouraged the community to participate in the Reyes Adobe Days event scheduled for October 3-5, 2008.

Councilmember Schwarz spoke about water conservation and encouraged residents to check the sprinkler heads on their irrigation systems for any water runoff, and also noted that Southern California Edison has prepared a Residential Energy Guide, offering energy saving tips, that is available on their website.

Mayor Edelston unveiled the new Agoura Hills Healthy City logo, selected by the Community Services Committee, and spoke about and encouraged the residents to take advantage of the upcoming Healthy City programming that will be offered through the City.
