### **CITY COUNCIL DISCUSSION/ACTION**

11. Request for Approval of an Agreement with the Buxton Company for the CommunityID and Scout Programs

Following presentation of the staff report, Mayor Weber opened the floor for public comment.

There were no public speakers.

**ACTION:** Following discussion, the motion by Councilmember Edelston, to approve the agreement with the Buxton Company, was seconded by Councilmember Schwarz, and unanimously approved 5-0.

### **CITY COUNCIL, STAFF COMMENTS**

Councilmember Schwarz reported that he and Brad Rosenheim, on behalf of the Business Task Force, visited the Ralph's shopping center and tenants had expressed their concerns with not being able to display their wares outside their shops. Councilmember Schwarz requested staff review the ordinance and consider a temporary option, similar to the temporary banner program.

Councilmember Kuperberg spoke about the sunset of the temporary banner program, suggested an additional 60-day extension, and recommended staff bring back an item for consideration by the City Council at the next meeting. The City Council unanimously consented to direct staff to bring back a Consent Calendar item for consideration on January 28, 2009.

Mayor Pro Tem Koehler requested the meeting be adjourned in memory of Yerba Buena special education teacher Elizabeth "Liz" Rogers who unexpectedly passed away last Wednesday.

Mayor Weber reported that he visited three shopping centers and the individual tenants had expressed concern that their property managers would not allow them to display the banners, even though the City has waived the fee and temporarily encouraged them.

At 8:50 p.m., on a motion by Councilmember Schwarz, second by Councilmember Edelston, the City Council unanimously consented to adjourn the meeting, in memory of Elizabeth "Liz" Rogers, to 7:00 p.m., Wednesday, January 28, 2009, for a Regular Meeting of the City Council in the Council Chambers of the Civic Center with a Closed Session at 6:00 p.m. The Civic Center is located at 30001 Ladyface Court, Agoura Hills, California.
