As a condition of approval for planning case number 06-CUP-006 (Chabad of the Conejo), the applicant was required to dedicate an approximate 12-foot-wide strip of right-of-way along the property frontage to match the adjacent property lines.

Article 3, Section 66745 of the State Subdivision Map Act and Chapter 6, Part 1, Division 2 (et al.) of the Agoura Hills Municipal Code allows for the dedication of property to achieve sufficient right-of-way in the event the City wishes to widen the road in the future.

The attached right-of-way documents have been reviewed and approved by the City Engineer.

# RECOMMENDATION

Staff respectfully recommends the City Council:

- 1. Adopt Resolution No. 09-1518, which makes the findings required by the State Subdivision Map Act and City of Agoura Hills Municipal Code, and accepts the portion of property located at 30345 Canwood Street; and
- 2. Authorize the City Clerk to record the resolution with the Los Angeles County Recorder.

# A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF AGOURA HILLS, CALIFORNIA ACCEPTING THE RIGHT-OF-WAY DEDICATION WITHIN THE PROPERTY AT 30345 CANWOOD STREET IN AGOURA HILLS

THE CITY COUNCIL OF THE CITY OF AGOURA HILLS HEREBY FINDS, RESOLVES AND ORDERS AS FOLLOWS:

Section 1. That portion of the of the Subdivision of Lot "E" allotted to the Estate of Jose Reyes, in the Partition of the Rancho Las Virgenes, Superior Court Case No. 2898, in the City of Agoura Hills, as per Map recorded in Book 52, Page 63 of Miscellaneous Records, in the Office of the County Recorder of the County of Los Angeles as described in the attached Exhibits A and B, shall be, and are hereby, dedicated to the City of Agoura Hills. Such dedication is made pursuant to Article 3, Section 66745 of the State Subdivision Map Act and Chapter 6, Part 1, Division 2 (et,al) of the Agoura Hills Municipal Code which provides the authority and the procedure for dedications.

<u>Section 2.</u> The City Council accepts the portion of land along the frontage into the City's public right-of-way inventory.

<u>Section 3.</u> The City Council finds that any and all easements for utilities, public and private, in place on the dedicated portion of said easement that are in use or that will be affected by the dedication shall remain until so vacated by said utilities.

Section 4. Those portions of land, as described in Section 1 and in attached Exhibits A and B, shall be recorded as dedicated from this date forward as they will serve the needs of the City as established by the City General Plan.

### Parcel 1

That portion of the Subdivision of Lot "E" allotted to the Estate of Jose Reyes, in the Partition of the Rancho Las Virgenes, Superior Court Case No. 2898, in the City of Agoura Hills, as per Map recorded in Book 52, Page 63 of Miscellaneous Records, in the Office of the County Recorder of said County, described as follows:

Beginning at a 1 inch iron pipe in the North Line of Ventura Boulevard, 60 feet wide, distant North 84° 20' East 43.98 feet from the southwest corner of that 37.71 acre tract of land described in deed to Espiritu R. De Chavez, recorded in Book 3887, Page 386 of Official Records; thence North parallel with the West Line of said 37.71 acre tract 180.04 feet to the true point of beginning; thence North parallel with the said West Line 257.67 feet to a <sup>3</sup>/<sub>4</sub> inch iron pipe; thence parallel with the North Line of said Ventura Boulevard North 84° 20' East 100 feet to a 1 inch iron pipe in the East Line of that 9.24 acre tract of land allotted to Joe P Chavez, recorded in Book 3983, Page 288 of Official Records; thence south along said line of that 9.24 acre tract 253.87 feet to a point in said line which is distant 183.84 feet along said produced to a <sup>3</sup>/<sub>4</sub> inch iron pipe in the said North Line of Ventura Boulevard; thence South 78° 54' 29'' West 100.45 feet to the true point of beginning.
