

**NOTICE INVITING SEALED BIDS
FOR
2008-2009 ANNUAL CONCRETE REPAIR PROJECT
NIB 08-02**

PUBLIC NOTICE IS HEREBY GIVEN that the City of Agoura Hills as AGENCY, invites sealed bids for the above-stated project and will receive such bids in the offices of the City Clerk, 30001 Ladyface Court, Agoura Hills, California 91301, up to the hour of 10:00 a.m., on Tuesday, March 31, 2009, at which time they will be publicly opened. Copies of the Plans, Specifications, and contract documents are available from the City of Agoura Hills, 30001 Ladyface Court, Agoura Hills, California, upon payment of a \$25 non-refundable fee if picked up, or payment of a \$30 non-refundable fee if mailed.

The work will be done on various streets and parks throughout the City. The scope of work includes removal and replacement of existing sidewalk, commercial and residential driveway aprons, curb and gutter, ribbon gutters, grinding of raised concrete, installation of root barriers, and construction of handicap ramps. The Contractor hired will be required to perform concrete repairs once in the 12-month period. At the mutual agreement of the City and the Contractor, the contract may be extended for up to four additional one-year periods. The extension shall be based on the terms, conditions, and bid prices of the initial contract. The unit prices established for the work may be increased or decreased annually based on the State of California Consumer Price Index (CPI). The initial term shall commence from the time a notice to proceed is issued and shall terminate one year from award.

Any contract entered into pursuant to this notice will incorporate the provisions of the State Labor Code. Compliance with the prevailing rates of wages and apprenticeship employment standards established by the State Director of Industrial Relations will be required. Copies of the prevailing wage rates are on file and are available for inspection in the offices of the City Clerk. Affirmative action to ensure against discrimination in employment practices on the basis of race, color, national origin, ancestry, sex, or religion will also be required. The AGENCY hereby affirmatively ensures that minority business enterprises will be afforded full opportunity to submit bids in response to this notice and will not be discriminated against on the basis of race, color, national origin, ancestry, sex, or religion in any consideration leading to the award of contract.

Bids must be prepared on the approved proposal forms in conformance with the **INSTRUCTIONS TO BIDDERS** and submitted in a sealed envelope plainly marked on the outside **“SEALED BID FOR 2008-2009 ANNUAL CONCRETE REPAIR PROJECT, NIB 08-02 – DO NOT OPEN WITH REGULAR MAIL.”** The bid must be accompanied by a cash deposit, certified check, cashier's check, or bidder's bond made payable to the AGENCY for an amount equal to 10 percent of the total amount bid as required by California law.

All bidders shall be licensed in accordance with provisions of the Business and Professions Code and shall possess a State Contractor's License, Class "A," or "C8" at the time a contract for this work is awarded. The AGENCY reserves the right to reject any or all bids, to waive any irregularity, and to take all bids under advisement for a period of 45 days.
