

**NOTICE INVITING SEALED BIDS
FOR
BUS SHELTERS PROJECT
NIB 08-03**

PUBLIC NOTICE IS HEREBY GIVEN that the City of Agoura Hills as AGENCY, invites sealed bids for the above-stated project and will receive such bids in the offices of the City Clerk, 30001 Ladyface Court, Agoura Hills, California 91301, up to the hour of 10:00 a.m., on Friday, April 17, 2009, at which time they will be publicly opened. Copies of the Plans, Specifications, and contract documents are available from the City of Agoura Hills, 30001 Ladyface Court, Agoura Hills, California, upon payment of a \$30 non-refundable fee if picked up, or payment of a \$35 non-refundable fee if mailed.

The work will be done at five locations throughout the City. The scope of work for the base bid includes, but is not limited to: installing a total of seven bus shelters, removal and replacement of existing sidewalk, removal and replacement of existing curb and gutter, and electrical wiring. In addition, one alternate bid item is included which consists of potentially installing a different roof support structure instead of the roof support structure included in the base bid. The final contract award will be based on the lowest responsible base bid. The Contractor hired will be required to perform the work after July 1, 2009. The extension shall be based on the terms, conditions, and bid prices of the initial contract. The initial term shall commence from the time a notice to proceed is issued.

Any contract entered into pursuant to this notice will incorporate the provisions of the State Labor Code. Compliance with the prevailing rates of wages and apprenticeship employment standards established by the State Director of Industrial Relations will be required. Copies of the prevailing wage rates are on file and are available for inspection in the offices of the City Clerk. Affirmative action to ensure against discrimination in employment practices on the basis of race, color, national origin, ancestry, sex, or religion will also be required. The AGENCY hereby affirmatively ensures that minority business enterprises will be afforded full opportunity to submit bids in response to this notice and will not be discriminated against on the basis of race, color, national origin, ancestry, sex, or religion in any consideration leading to the award of contract.

Bids must be prepared on the approved proposal forms in conformance with the INSTRUCTIONS TO BIDDERS and submitted in a sealed envelope plainly marked on the outside **“SEALED BID FOR BUS SHELTERS PROJECT, NIB 08-03 – DO NOT OPEN WITH REGULAR MAIL.”** The bid must be accompanied by a cash deposit, certified check, cashier's check, or bidder's bond made payable to the AGENCY for an amount equal to 10 percent of the total amount bid as required by California law.

All bidders shall be licensed in accordance with provisions of the Business and Professions Code and shall possess a State Contractor's License, Class "A," at the time a contract for this work is awarded. The AGENCY reserves the right to reject any or all bids, to waive any irregularity, and to take all bids under advisement for a period of 45 days.
