SUBJECT: ADOPT RESOLUTION NO. 09-1525, APPROVING THE INSTALLATION

OF 35 FEET OF RED CURB TO RESTRICT PARKING ON THE WEST SIDE OF THE WESTERLY DRIVEWAY ENTRANCE LOCATED AT

30423 CANWOOD STREET

Public safety concerns have recently been expressed regarding vehicles that have been parking along the west side of the westerly driveway entrance located at 30423 Canwood Street (see attached). The parked vehicles obstruct the visibility of motorists wishing to make a left turn out of the driveway to go eastbound on Canwood Street.

In light of this, the City's Traffic Engineer recommends the installation of 35 feet of red curb, along the west side of the west driveway entrance. This will ensure that parked cars are not obstructing the views of motorists, and that the safety of both drivers and pedestrians is protected at this driveway entrance.

With City Council approval, red curb would be installed by the Los Angeles County Public Works Department within four weeks. In addition, the Lost Hills Sheriff's Traffic Division will be notified of the changes, allowing for immediate enforcement of the new restrictions.

RECOMMENDATION

Staff respectfully recommends the City Council adopt Resolution No. 09-1525 approving the installation of 35 feet of red curb to restrict parking on the west side of the westerly driveway entrance located at 30423 Canwood Street.

RESOLUTION NO. 09-1525

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF AGOURA HILLS, CALIFORNIA, APPROVING THE INSTALLATION OF 35 FEET OF RED CURB TO RESTRICT PARKING ON THE WEST SIDE OF THE WESTERLY DRIVEWAY ENTRANCE LOCATED AT 30423 CANWOOD STREET

WHEREAS, public safety concerns have been expressed for the need to establish a parking policy that prohibits parked vehicles from creating line-of-sight problems; and,

WHEREAS, Section 22507 of the California Vehicle Code permits local authorities to restrict parking on streets under their jurisdiction; and,

WHEREAS, the City's Traffic Engineer has determined there is a line-of-site problem 35 feet west of westerly driveway located at 30423 Canwood Street, and thus a need to restrict vehicles from parking any time along this portion of roadway to maintain clear line-of-sight; and,

WHEREAS, the City's Traffic Engineer is recommending that 35-feet of red curb be installed along the west side of the westerly driveway entrance located at 30423 Canwood Street to maintain line-of-sight; and,

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Agoura Hills adopts Resolution No. 09-1525, establishing parking restrictions on the west side of westerly driveway entrance located at 30423 Canwood Street by installing 35 feet of red curbing.
