### General Plan Update—2035

Agoura Hills is updating its General Plan. State law requires each city and county to prepare and adopt a comprehensive long-range general plan for its physical development. A comprehensive general plan provides for a consistent framework for land use decision marking.


During the summer of 2005, the City mailed a survey questionnaire to all households in the City to gain an understanding of land use, circulation and other issues of concern to its citizens.

Meetings with key City stakeholders were held in spring 2006. The "Big Ideas" public meeting was held in December 2006, where citizens provided input to the City Council, Planning Commission and City staff about what the General Plan Update (GPU) should include.

Since then, City staff, consultants, and the General Plan Advisory Committee (GPAC) have been working to prepare the City's General Plan Update (through the Year 2035). This citizen input has formed the basis of our GPU.

The GPAC is comprised of two City Council members, two Planning Commissioners, and six atlarge residents appointed by the City Council.

Since January 2009, the GPAC has been regularly meeting with City staff and consultants to create goals and policies that would guide the General Plan. Implementation measures ensure that the goals and policies are realized.



They are often specific tools and programs that need to be established to carry out the goals and policies.

There are 12 "study areas" in the GPU. While there is limited vacant land in the City that is available and feasible for development, the development cycle is such that existing developed areas could undergo changes over the next 25 years. The study areas are particular locations in the City where change might occur from now through 2035. None of the study areas encompass residential neighborhoods or open space areas. These two types of areas were seen as stable. Some study areas are being considered for additional types of land uses, but for the most part, the GPU is seeking to improve the appearance or enhance the pedestrian amenities of the areas.

The full Draft General Plan Update document is currently being prepared. Each element of the document will include goals, policies and implementation measures, along with background data and context within which to view



An Environmental Impact Report (EIR) per the California Environmental Quality Act (CEQA) is being prepared to assess potential impacts resulting from

implementation of the GPU.

The Draft GPU and Draft EIR are expected to be available fall 2009 for the public to review and comment.

The community meeting on July 28, 2009 will be to share information on the GPU with the public.
