**PROJECT DESCRIPTION:** The project consists of the adoption of a proposed update to the City of Agoura Hills General Plan (General Plan 2035). The current General Plan was adopted in 1993. The document is a comprehensive, long range plan for the physical development of the City through 2035. The General Plan contains goals and policies related to the following four major elements: Community Conservation and Development; Infrastructure and Public Services; Natural Resources; and Community Safety. The General Plan also contains an Implementation Program, which identifies how the various policies would be carried out.

**REQUEST:** Adopt the City of Agoura Hills General Plan 2035; certify the Final Program Environmental Impact Report (EIR), along with approval of a Statement of Overriding Considerations and approval of a Mitigation Monitoring and Reporting Program; and approval of a General Plan Amendment, all associated with adoption of the General Plan 2035.

**ENVIRONMENTAL DETERMINATION:** Final Program Environmental Impact Report (EIR), pursuant to the California Environmental Quality Act.

**DOCUMENT AVAILABILITY:** The Final Program EIR and the General Plan Update (General Plan 2035) are available for review at the Planning and Community Development Department at City Hall at 30001 Ladyface Court, Agoura Hills, CA 91301, between the hours of 7:00 AM and 5:00 PM on Monday – Thursday, and between 7 :00 AM and 4:00 PM on Fridays.
