SUBJECT: AWARD CONTRACT FOR PROFESSIONAL AUDIT SERVICES FOR

THE CITY OF AGOURA HILLS, THE AGOURA HILLS REDEVELOPMENT AGENCY, AND THE AGOURA HILLS CALABASAS COMMUNITY CENTER FOR THE THREE FISCAL YEARS BEGINNING WITH THE FISCAL YEAR ENDING JUNE 30,

2010

On January 27, 2010, City Council authorized staff to issue Requests for Proposals (RFP) for auditing services for the City of Agoura Hills, the Agoura Hills Redevelopment Agency, and the Agoura Hills Calabasas Community Center for the three fiscal years beginning with the fiscal year ending June 30, 2010, with the option of extending the agreement for two (2) additional one-year periods.

Staff requested bids from 17 firms and received responses from eight. Five of the firms were selected to be interviewed by the Finance Committee and staff on March 10, 2010. Following the interviews, the committee ranked the firms and then opened the sealed bids. The bid results for three years were as follows:

Vavrinek, Trine, Day and Company, LLP (VTD) is the recommended firm following the interviews and is the low bidder for the three years. VTD serves numerous cities and counties throughout the State and their references stated that they were in good standing. Their most recent peer report states that they received the highest peer review rating of "passed".

RECOMMENDATION

Staff respectfully recommends the City Council and Redevelopment Agency award the contract for auditing services for the City of Agoura Hills, the Agoura Hills Redevelopment Agency, and the Agoura Hills Calabasas Community Center for the three fiscal years beginning with the fiscal year ending June 30, 2010, to Vavrinek, Trine, Day and Company, LLP; and authorize the Mayor to sign the contract agreement.
