The meeting was called to order at 7:00 p.m. by Mayor Koehler.

CITY COUNCIL DISCUSSION/ACTION

8. Discussion Regarding Proposed Amendments to City Council Norms

ACTION: By City Council consensus, this item was deferred until a future date, to be determined.

CITY COUNCIL, STAFF COMMENTS

City Attorney Steele announced the California Supreme Court denied a petition of review that was filed by the plaintiff in the lawsuit challenging the Environmental Impact Report (EIR) for the Agoura Village Specific Plan, which should be the last step in the lawsuit. As a result, the City's EIR has been certified and found to be legally adequate. Councilmember Kuperberg inquired if the City prevailed in the lawsuit and City Attorney Steele confirmed that it had.

Councilmember Edelston expressed his appreciation for Reyes Adobe Days and spoke about attending the *Taste of Conejo* event sponsored by the Greater Conejo Valley Chamber of Commerce. Mayor Koehler noted that the City Council had attended and it was an excellent Chamber event.

Councilmember Kuperberg spoke about the *Taste of Conejo* event, the art show at the *Night at the Adobe* event, the 2010 Cultural Arts Initiative, and noted there is general excitement in the community regarding cultural events.

Mayor Koehler noted that there were four generations of Van Dykes, including Dick Van Dyke, at the Reyes Adobe Days parade and requested staff extend a formal thank you letter to the family for their participation in the event.

Councilmember Weber spoke about the Reyes Adobe Days events, including his sentiments regarding leading the Pledge of Allegiance at the Gymkhana event, the increase in participation by the community, and thanked staff for their efforts and commitment. He then reported that he and Mayor Koehler had attended the Valley Cultural Center's 35th Anniversary Gala Event honoring Brad Rosenheim as the Clyde Porter Humanitarian Award recipient.

Mayor Koehler noted that he and Councilmember Weber attended the gala to honor Brad Rosenheim for his many accomplishments and service to our community.

Mayor Pro Tem Schwarz noted that Brad Rosenheim was a neighbor of his and he believes in community and family. He spoke about the volunteers in the City, how amazing they are, and extended a thank you to every person who volunteered and contributed to the success of the Reyes Adobe Days events. Mayor Pro Tem Schwarz also spoke about the Greater Conejo Valley Chamber of Commerce and supported their efforts to participate and drive business in our community and looked forward to working with them.
