#### CITY COUNCIL CONTINUED PUBLIC HEARING/ORDINANCE

10. Conduct a Continued Public Hearing, Introduce, Read by Title Only, and Waive Further Reading of Ordinance No. 10-380; AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF AGOURA HILLS, CALIFORNIA, AMENDING DIVISION 3 OF PART 1 OF CHAPTER 6 OF ARTICLE IX OF THE AGOURA HILLS MUNICIPAL CODE, RELATING TO THE CITY'S UNDERGROUNDING UTILITIES ORDINANCE TO ALLOW FOR THE OPTION OF AN IN-LIEU FEE FOR DEVELOPMENT LOCATED WITHIN SPECIFIED AREAS OF UNDERGROUNDING DISTRICTS and Adopt Resolution No. 10-1606; A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF AGOURA HILLS, CALIFORNIA, ESTABLISHING UTILITY UNDERGROUNDING INLIEU FEES ON PORTIONS OF ROADSIDE DRIVE WITHIN UNDERGROUND UTILITY DISTRICT NO. 1, AS AUTHORIZED BY DIVISION 3 OF PART 1 OF CHAPTER 6 OF ARTICLE IX OF THE AGOURA HILLS MUNICIPAL CODE, - Continued from the Regular City Council Meeting of November 10, 2010

ACTION: Following discussion, the motion by Councilmember Koehler, to introduce, read by title only, and waive further reading of <u>Ordinance No.</u> <u>10-380</u>, was seconded by Councilmember Weber, and approved 4-1 on a roll call vote, with Mayor Pro Tem Kuperberg opposed.

#### CITY COUNCIL PUBLIC HEARING/ORDINANCE

11. Conduct a Public Hearing and Adopt Ordinance No. 10-381; AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF AGOURA HILLS, CALIFORNIA ADOPTING. BY REFERENCE. THE FOLLOWING MODEL CODES INTO HILLS CODE: AGOURA MUNICIPAL 2010 CALIFORNIA BUILDING, RESIDENTIAL, PLUMBING, MECHANICAL, ELECTRICAL, FIRE, GREEN BUILDING, PROPERTY AND MAINTENANCE, AND OTHER RELATED MODEL CODES, AND THEIR APPENDICES, AND REPEALING AND REPLACING CHAPTER 1 OF ARTICLE III, AND CHAPTERS 1, 2, 3, AND 4 OF ARTICLE VIII OF THE AGOURA HILLS MUNICIPAL CODE - The Ordinance was Introduced and the Public Hearing was Set at the Regular City Council Meeting of November 10, 2010

Staff recommended the following amendments, as suggested by the Las Virgenes Municipal Water District:

112.3.3 Authority to Disconnect Water Utility. The Building Official is hereby empowered to disconnect or to require in writing the discontinuance of the property owner to disconnect the water utility service to buildings, structures or premises, or portions thereof, or to fixtures, devices or materials where such buildings, structures or premises, or portions thereof, are determined to be a hazard to life, health, property or to the environment, or where they lack permits and required inspection approvals.

The Building Official is hereby empowered to disconnect or to require in writing the discontinuance of the property owner to disconnect the water utility service as a means of preventing, restraining, correcting or abating any violation of this code, or other relevant laws, ordinances, rules or regulations.

Following presentation of the staff report, Mayor Schwarz opened the Public Hearing.

There being no public speakers, Mayor Schwarz closed the Public Hearing.

ACTION: Following discussion, the motion by Councilmember Weber, to adopt

Ordinance No. 10-381, as amended, was seconded by Councilmember

Edelston, and approved 5-0 on a roll call vote.

#### CITY COUNCIL, STAFF COMMENTS

Councilmember Weber spoke about the Menorah lighting at City Hall and wished everyone a Happy Hanukkah, Merry Christmas, and Happy New Year.

Councilmember Kuperberg wished Councilmember Weber a Happy Birthday, applauded staff on the success of the City Council reorganization meeting, and noted that December 8, 2010, marked the 28<sup>th</sup> Anniversary of the City of Agoura Hills.

Mayor Schwarz spoke about community members Patty and Alan MacGregor and requested the meeting be adjourned in honor of Alan MacGregor, who recently fell and broke his hip.
