Each year, the Department of Resources Recycling and Recovery (CalRecycle), formerly the California Integrated Waste Management Board (CIWMB), offers the Household Hazardous Waste (HHW) Grant Program to assist local governments in implementing safe HHW programs that can include reuse, reduction and collection programs. These are competitive grants available to eligible applicants including cities and counties with direct responsibility for HHW management.

For the FY 2010/11 funding cycle, \$1,500,000 is available with a maximum award of \$150,000 for each jurisdiction. Applications must be submitted to CalRecycle by April 15, 2011, and agencies awarded grant funding will have until 2013 to expend their award. Grant award notifications are scheduled for June 2011.

Participation in the HHW Grant Program requires applicants to submit a resolution from the agency's governing body, authorizing participation in the program, and an Environmentally Preferable Purchasing and Practices Policy, along with the application. The attached resolution provides for five-year participation in the grant program, thereby not requiring subsequent resolution approvals for future grant cycles.

For the application submittal, staff is suggesting expansion of the existing Saturday ABOP (Antifreeze, Batteries, Oil, & Paint) Program where used oil, oil filters, water based paint, antifreeze and car batteries are collected and also enhance public education materials. Currently, the program is conducted on the first Saturday of the month in Agoura Hills, with the neighboring cities of Calabasas, Hidden Hills and Malibu conducting follow-up collections on the second and third Saturdays. Staff is proposing to pick up the fourth Saturday of the month that was cancelled by the City of Westlake Village in 2009 and is no longer being held. This will result in two available collections per month in Agoura Hills. The grant award would provide for two years of expanded service where Agoura Hills and participating City residents have the ability to conveniently bring more items for collection, in lieu of driving to farther county programs to dispose of them.

# RECOMMENDATION

Staff respectfully recommends the City Council approved Resolution No. 11-1623 authorizing participation in the FY 2010-11 CalRecycles Household Hazardous Waste Grant Program.

## **RESOLUTION NO. 11-1623**

# A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF AGOURA HILLS, CALIFORNIA, AUTHORIZING PARTICIPATION IN THE DEPARTMENT OF RESOURCES RECYCLING AND RECOVERY (CALRECYCLE) HOUSEHOLD HAZARDOUS WASTE GRANT PROGRAM

WHEREAS, Public Resources Code sections 40000 et seq. authorizes the Department of Resources Recycling and Recovery (CalRecycle), formerly known as the California Integrated Waste Management Board, to administer various Grant Programs (grants) in furtherance of the State of California's (State) efforts to reduce, recycle, and reuse solid waste generated in the State, thereby preserving landfill capacity and protecting public health and safety and the environment; and

**WHEREAS**, in furtherance of this authority, CalRecycle is required to establish procedures governing the application, awarding, and management of the grants; and

**WHEREAS**, CalRecycle Grant Application procedures require an Applicant's governing body to authorize by resolution its approval for submittal of the Grant Application(s) identified below, and the designation by job title of the individual authorized to execute all Grant documents on behalf of the City of Agoura Hills; and

**WHEREAS**, if awarded, City of Agoura Hills will enter into a Grant Agreement with CalRecycle for implementation of the Grant;

**NOW, THEREFORE, BE IT RESOLVED,** that the City Council of the City of Agoura Hills authorizes the submittal of application to CalRecycle for the Household Hazardous Waste Grant Program for which City of Agoura Hills is eligible; and

**BE IT FURTHER RESOLVED**, that the City Manager, or his/her designee, is hereby authorized and empowered to execute in the name of the City of Agoura Hills, all grant documents, including but not limited to, applications, agreements, amendments, and requests for payment, necessary to secure grant funds and implement the approved grant project; and

**BE IT FURTHER RESOLVED**, that these authorizations are effective for (5) years from the date of adoption of this resolution (from Wednesday, March 23, 2011, through Wednesday, February 27, 2016).

# Recycled-Content Purchasing and Waste Reduction & Recycling Policy

### Purpose

The City of Agoura Hills recognizes the importance of waste reduction, reuse, and recycling practices, where applicable, as it provides avenues for environment and resource preservation. These avenues provide various benefits for the environment. The City provides that all departments shall, whenever possible, purchase when and where applicable, recycled products and recycled materials to meet their needs. The City Council of the City of Agoura Hills recently enacted an Environmental Responsibility Committee whose goal is to move the City and community toward more sustainable living. One of several "first step goals" was to examine internal methods to reduce waste, as well as enhance recycling efforts.

This policy is enacted to demonstrate compliance with California's Waste Management Reduction Act and to foster market development for recycled products.

### Definitions

The following are definitions to assist staff with understanding basic concepts to assist in implementing this policy. The definitions are meant to assist, not be all inclusive, and provide guidance.

**Recycled Material** - Waste material and by-products that have been recovered or diverted from the solid waste stream and that can be utilized in place of raw or virgin material in the production of a product. Recycled materials may consist of material derived from postconsumer waste, manufacturing waste, industrial scrap, agricultural waste, and other items, all of which can be used in the manufacture of new products.

**Post-Consumer Recycled Materials** - A finished material or product that has served its intended use and would normally be disposed of as solid waste. Examples of post-consumer recovered materials include, but are not limited to, old newspapers, office paper, yard waste, steel, glass, aluminum cans, plastic bottles, oil, asphalt, concrete, and tires.

**Practicable** - Sufficient in performance and available at a reasonable price within a reasonable time period.

**Pre-Consumer** - Materials or by-products generated after manufacturing of a product is completed, but before the product reaches the end-use consumer. Examples of pre-consumer recovered materials include, but are not limited to; obsolete inventories of finished goods, rejected unused stock and paper wastes generated during printing, cutting, and other converting operations.

### **General Policies**

A. All City of Agoura Hills departments shall use recycled products whenever practicable.

Special emphasis shall be placed on the purchase of products manufactured with postconsumer recycled materials. Paper products should be purchased with no less than 30% recycled content.

- B. All City of Agoura Hills departments may, at their option and with purchasing concurrence, require procurement of designated recycled products or recycled products above the levels required by this policy.
- C. All employees in the City of Agoura Hills will actively participate in City's source separation their personal workspace refuse utilizing separate containers for waste and white goods. Employee will implement the use of double-sided copies of all city reports, and use double-side paper for personal work notes.
- D. The City of Agoura Hills shall promote the use of recycled products publicizing its procurement policy whenever practicable.

### Responsibilities of Recycled Products and Materials Coordinator

The Assistant to the City Manager and/or his designee shall coordinate the implementation of this policy. He/she will establish a list of recycled products that shall be purchased by all City departments, whenever practicable, and will develop the mechanism for maintenance, additions, and deletions to the list of recycled products available for procurement. Maintenance of the list will include addition of new products containing recycled material, as they become available, and make available to departments specifications on the new products, along with a list of suggested uses. The Assistant to the City Manager and/or his designee will also work with all departments to establish minimum recycled content standards for designated recycled products to maximize recycled product availability, recycled content, and competition. The Assistant to the City Manager will also be responsible for annual policy review.

### Waste Reduction and Recycling Policies

The City of Agoura Hills will act to make resource conservation an integral part of its waste reduction and recycling programs. The practice of discarding materials used in the City facilities is wasteful of natural resources, energy, and money.

It will be the policy of City of Agoura Hills to implement the following actions:

- 1. The City of Agoura Hills will integrate the concept of resource conservation, including waste reduction and recycling, into its environmental programs. Programs include, but are not limited to: 1) office recycling; 2) purchases of non-toxic materials where applicable; etc.
- The City of Agoura Hills will decrease the amount of waste of consumable materials by:

   a) reduction of the consumption of consumable materials wherever possible;
   b) full utilization of all materials prior to disposal;
   and c) minimization of the use of non-biodegradable products wherever possible.
- 3. The City of Agoura Hills will cooperate with, and participate in, recycling efforts being made by the City and County. As systems for the recovering of waste and recycling are developed within the City, it will participate by appropriately separating and allowing recovery of recyclable waste products.
- 4. The City of Agoura Hills will, where applicable and economically viable, purchase recycled products.

5. Representatives of the City will actively advocate, where appropriate, for resource conservation practices to be adopted at the local, regional, and national levels.

Dynamic Policy

This policy is meant to be dynamic, requiring review and updating as necessary. It must, by no means, be constructed or interpreted as an all inclusive document. Changes recommended and implemented by the Environmental Responsibility Committee and/or staff will be incorporated into this policy, where applicable.
